## PAYMENT AND CLOSING TIME

## WITHDRAWAL OF ENTRIES

An Exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by telephone, however written or e-mail notification must be received by the Show Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the show.

Any handler unable to attend these trials due to experiencing COVID-19 SYMPTOMS, after entries close, will receive a credit to any future CKC events hosted by the SKOC. Credits will expire after one year. Entries from this trial will be considered equal value to the credit towards future trial(s).

## HIGH DOUBLE COMBINED HIGH TRIPLE COMBINED

High double combined will consist of the highest combined scores from Advanced B and Excellent B to receive a rosette in each trial.

High triple combined will consist of the highest combined scores from Advanced B, Excellent B and Master to receive a rosette in each trial.

Note: Competitors will be responsible to keep track of their scores and present them to the secretary at the end of each trial for verification. Ties will be broken by the fastest combined time.

## MAT TIME

Friday evening 5:30 – 8:30pm - \$15.00 per 10 minutes. Sign up by emailing [jerri.mcphee@sasktel.net](mailto:jerri.mcphee@sasktel.net). Mat time MUST be pre-booked and prepaid (via e-transfer) to hold your spot. There will be no refunds for mat time.

## DAY-OF-TRIAL ENTRIES

Day-of-trial entries will be accepted both March 20 and 21, 2021. Entries must be made at least 30 minutes before the start of the trial. Day-of-trial entries will be cash only.

## DIRECTIONS: PIKE LAKE HALL

From 22nd Street West (in Saskatoon), turn left onto Highway 7 (just past the Walmart and Lowe's). Follow for 5 km and turn left onto Highway 60. Continue on Highway 60 for 20 km then turn left onto Churchill Avenue. Drive down Churchill Avenue for 600 meters (first intersection) and turn right onto Pippin Street. Pike Lake Community Hall is located approximately 2/3 of the way down this street or 170 meters on the left (between the Pike Lake Fire Hall and Pike Lake Community School).

## BENCHING

No Benching at this time. Subject to change.

## ADDITIONAL INFORMATION

- ◆ The scoop-up requirements will be strictly enforced.
- ◆ There will be **no "In Transit"** area provided.
- ◆ There will be no "over night" kenneling.
- ◆ Only approved CKC collars will be allowed.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ THE PRECINCTS of these trials shall be the Pike Lake Hall building & grounds.
- ◆ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CKC, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W.
- ◆ The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
- ◆ All dogs must be under complete control at all times.
- ◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

## PLEASE NOTE:

**When entering the same dog in multiple classes a separate entry form MUST be filled out for EACH class.**

**There will be no food or drinks available for purchase.**

*Payment may be made using a credit card (VISA, MasterCard, American Express). Paper entries can only be paid by cheque.*



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

## COVID-19 CKC RALLY OBEDIENCE TRIAL ALLOWABLE CHANGES

- ◆ Five (5) handlers allowed per walk through, in running order.
- ◆ Only the dog and handler in the ring and the dog and handler on deck are allowed in the building (subject to COVID-19 guidelines).
- ◆ For off leash classes, the handler will place their leash in a designated spot and pick it up after their run. The ring steward will NOT bring your leash to you. Your dog must leave the ring on-leash and under control.
- ◆ Armband Numbers will be placed on a chair to be picked up by handlers on your way to the ring for the walk through.
- ◆ Qualifying Rosettes, ribbons and score sheets will be left on a table for handlers to pick up if they wish at end of their class and removed prior to the end of the next class. No ribbon/rosette presentations in the ring.
- ◆ Special prizes will be verified by Trial Chair or Event Secretary and will be placed out at time of award in specified location.
- ◆ There will be no printed catalogues. Electronic Copies may be provided by email.
- ◆ Individual printed courses will not be available. They will be posted inside and outside the building.

## COVID-19 INFORMATION – SUBJECT TO CHANGE

- ◆ All Saskatchewan Health Authority (SHA) regulations will be followed.
- ◆ If you are exhibiting ANY symptoms of COVID-19, please do not attend the trials. Any handler unable to attend these trials due to exhibiting COVID-19 symptoms after entries close will receive a credit to any future CKC event hosted by the Saskatoon Kennel & Obedience Club. Credits will expire after one year.
- ◆ MASKS will be mandatory at time of Premium List for all competitors on the precinct of the trial. New restrictions may be made at time of event according to SHA regulations.
- ◆ NO Spectators
- ◆ **ALL competitors will be required to sign a waiver form and must turn waiver in at venue upon arrival, before competing. Waiver is available on DogShow.ca**
