I have been FCI-judge since 1975 and I am registered in the German judging list. I am specialist for 63 different breeds and in 1987 I qualified as an allrounder.

I started breeding Basset Hounds about 35 years ago. My bitch was the first Basset Hound of all FCI-countries to achieve the title "Champion International de Beaute". My first male Basset Hound won 13 Champion-titles and was awarded 3 working certificates.

As I always longed to have a big dog, on behalf of my birthday in the year 1985 my husband surprised me with a Doberman. This dog "Graf Guido vom Franckenhorst", bred in the Netherlands held 20 Champion-titles in 13 different countries and sired many bitches coming from almost all parts of the world with the result of more than 1.600 puppies.

We lived in South Africa for five years, but after the death of my husband I moved back to Germany in 2003.

I have judged in nearly all parts of the world, for instance in Australia, Austria, Azerbaijan, Belgium, Belarus, Brazil, Canada, Chile, China, Croatia, Czech.

Republic, Cyprus, Denmark, Estonia, Finland, France, Germany, Gibraltar, Great Britain, Greece, Hungary, Indonesia, Ireland, Israel, Italy, Kasachstan, Kenya, Latvia, Lithuania, Luxembourg, Monaco, Netherlands, New Zealand, Norway, Philippines, Peru, Poland, Portugal, Russia, Serbia, Slovakia, South Africa, South Korea, Spain, Sweden, Switzerland, Taiwan, Thailand, Ukraine, USA, Zimbabwe.

This is not the first time I am judging in Canada. I am looking forward to this show.

Ms Dowell was born and raised in the Seattle area. My interest in dogs started when I was a small child. My mother always said that I never found an animal I didn't like. This was true then and still today. Ms Dowell was raised with German Shepherds. Later she bred and owned silver Miniature Poodles and then came along the breed she fell in love with – Dandie Dinmont Terriers. Ms Dowell obtained her first Dandie from the Wolks in California, at this time she started a lifelong friendship with Dr Josephine Deubler a leading Dandie expert.

Over the years Ms Dowell along with her husband Steve have been lucky to have bred and shown many wonderful Dandies. Thanks must go to some outstanding expert handlers who have helped us along the way; Jimmy Butler, Pat Tripp, Timmy Brazier, Stephen Shaw, Hugo Reiping, Joe and Pauline Waterman, Winnie Heckman and Bob Bartos. Our friendships with them have made our lives fuller.

In 1972, with the encouragement of Sarah Swift and help from the AKC and Len Brumby, Ms Dowell applied for her judges license commencing with one breed – Dandie Dinmont Terriers, and has continued from there.

Dr. Robert A. Indeglia, of Narragansett, Rhode Island, is a native New Englander whose parents were Cocker Spaniel breeders of the 1930s and '40s. He was showing Cockers by the late '40s, and has owned and shown several breeds, but is best known for his long association with the Norwegian Elkhound.

An active member of the Norwegian Elkhound Association of America, he has served the club as president, board member, and AKC delegate, and chaired the breed's first standard revision committee. Dr. Indeglia has bred more than 40 Elkhound litters and shown 50 champions in the breed.

Dr. Indeglia began judging Elkhounds in 1971 and is now approved for the Hound, Non-Sporting, and Working groups, as well as Labrador and Golden retrievers. He most recently judged at the AKC/Eukanuba National Championship in 2003.

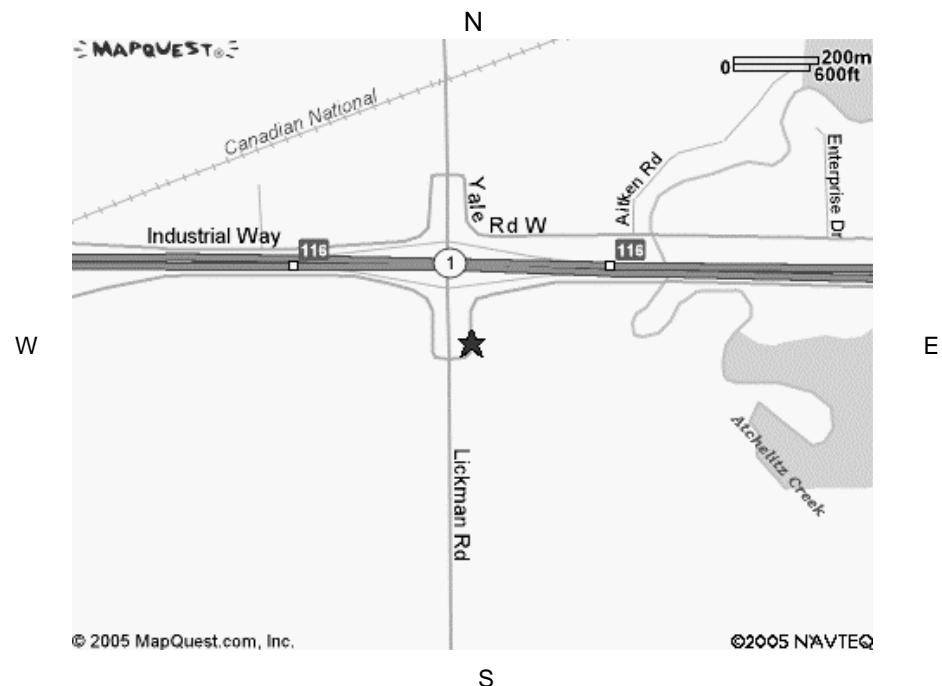

2. There will be an area designated for the exercising of dogs. No dogs will be allowed to exercise elsewhere on the grounds. The Renaissance Dog Association ask that you pick up after your dogs. Offenders may lose show privileges.
3. Using the building facilities is a privilege, please be considerate. Dogs are not allowed in the washrooms.
4. The Welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.
5. The Club is not responsible for lost or stolen property from exhibitors or vendors/concessions.
6. The Club reserves the right to refuse an individual's entries, for just cause
7. Delays waiting for dogs are not possible and handlers with several breeds **MUST** arrange for alternate handlers if judging times for their dogs' conflict.
8. The Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors. (See 'AGREEMENT' on the back of the entry form)

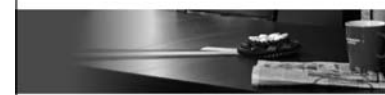

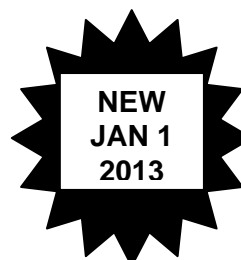

- In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.



GRAND CHAMPION

(synopsis only – full details posted on CKC website)
Points towards a Grand Championship cannot be gained until a dog completes its Canadian Championship. The accumulation of points began January 1, 2013. The dog must compete in the Specials Only class. Twenty points are needed for the title (the forms are available for download from the

CKC website and it is the responsibility of the owner to keep track and when they reach the 20 points, submit the form to CKC who will verify the wins, and if correct will issue a certificate). In the 20 points there needs to be a minimum of 1 Best of Breed and at least 2 – 2 point wins. The scale of points is the same as for regular championships. A judge will select Best of Breed, Best of Opposite Sex, Select Dog, Select Bitch (the latter 2 will be chosen from the remaining Specials dogs competing, if any in competition). The points are based on the total number of dogs defeated



RULES GOVERNING THESE SHOWS

4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM THE ENTRY WAS MADE.
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points (effective January 1, 2012) (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)
