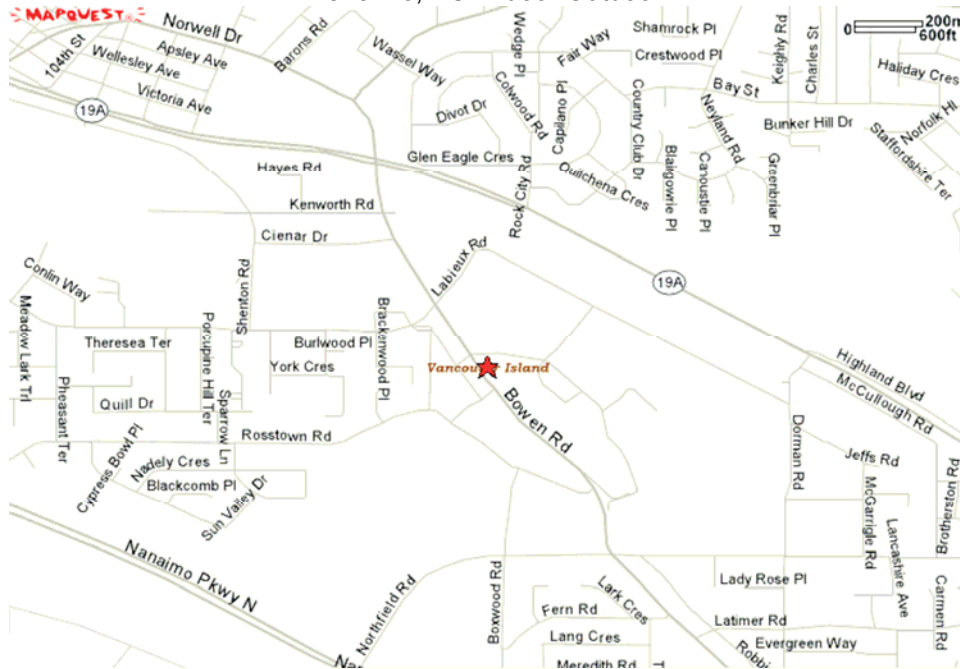

MICHEL CHALOUX

I have been involved with German shepherd dog (GSD) all my life. My father registered our kennel with the Canadian Kennel Club in 1955. I'm a registered pharmacist, graduated from Montreal University in 1980, currently Director of the Pharmacy Department at the "Ahuntsic-Montreal-Nord Health Care Center" in Montreal. This is a major Hospital Health Care Center of more than 1,000 beds. My main interest with German Shepherd Dog was mostly in handling dogs, finishing my first champion in July 1970 at the GSDC of Ottawa specialty show. I was the owner-handler of the first Canadian National Futurity Victor in 1974. In 1981, I handled the Canadian Grand-Victor and finished him in USA. At the same National in 1981, my own bitch (owner-handled) finished her Championship and went on to be WB and Select #3 (AOM). In my handling career, I have finished more than 100 champions including 10 select titles (AOM) at the Canadian National. I won multiple B.I.S.S. and multiple group wins at some of the most prestigious all-breeds shows in Canada. I had the privilege to handle of the top German Shepherds Dogs in Canada. I'm presently a CKC conformation judge for Best in Show. I'm also approved to judge Sporting, Working and Herding groups. I have judged multiple specialty shows, Regional and National Futurity shows and all-breeds shows in Canada, USA, Mexico and Australia. I had the privilege to be elected by "German Shepherd dog breeders" to judge the USA National in 2002 and 2008, the Mexican National in 2003 and the Canadian National in 1999 and 2005. I'm bilingual, speaking and writing French and English. My mother tongue is French.

In Memoriam



WILLIAM CUNNINGHAM

I'll begin at the beginning I registered my first litter in 1963 and started in obedience, completing a C.D. title on a Miniature Poodle. I became infatuated with the conformation, purchased a show dog and became a successful breeder. I bred and owner handled the top producing Standard Poodle in breed history, I also bred and handled the dam of the top-winning Poodle in breed history. I am now finishing my twelfth generation champions in both Standard Poodles and tenth in Shih Tzu I have also bred many Hound champions. 41/2 Years ago I started in Brussels Griffons, and this march I was winners bitch at are National with my 8 month old bitch from the bred by class and received an award of merit. It finished her with 4 majors and 3 best of breed over the top winning griffs in the country. I became a licensed handler in 1972 and was quite successful. I was a zone REP for the P.H.A. I was licensed to handle Dobermans, Standard and Giant Schnauzers in this group, all toys, all non-sporting and all hounds. I handled the top Maltese in the country, several top Poodles in all three varieties and several Shih Tzu (including the youngest Shih Tzu) to ever win an all breed Best In Show. I became involved in Br. Griffons 3 years ago and have finished 5, (3 of which I bred).

When I decided to become a Judge, I set my goal as to someday be an All Breed Judge. I have worked very hard in all the breed's I now judge, still attending Seminar's, Breed Study Group's National Specialties and continue to discuss the breeds with my mentor's and reputable breeder's. I still remain active as First Vice/president of THE POODLE CLUB OF AMERICA, on the board of the Orlando Poodle Club, President of the Mid-Florida Judges Study Group, Vice /President and Show Chairman of the Central Florida Shih Tzu Club. I also serve on the Education Committee for, the National Shih Tzu club, and Poodle Club of America think I have been observed by almost every A.K.C.Rep, and I have not (to the best of my knowledge) had any negative reports. I do try at all times to be very courteous to the Exhibitors, and very easy handed on young dogs and puppies. I personally think this comes from being a breeder, handler.

Introducing Our Distinguished Panel Of Judges



BRUCE FRASER began training Miniature Schnauzers for conformation with his 1st Miniature Schnauzer in 1986. Catching the show bug after taking Best Puppy in Show and Group Third the first weekend out, next on the horizon was a breeding program, focusing on Black Miniature Schnauzers. There have been many CKC and AKC champions and obedience trial champions produced by “Advocate” .Bruce, a lawyer by profession, became a CKC licensed obedience trial judge in 2004 and an all class Rally judge in 2008. In conformation, Bruce is licensed for all terriers (Group 4) and all toys (Group 5). Bruce enjoys judging throughout Canada and from Washington State south to Palm Springs in the USA.

I started out in the purebred dog world showing Yorkshire Terriers in 1968. From there I went to Bullmastiffs and thus became very interested in showing and judging.

I spent over 30 years under the "Shayla" prefix breeding and showing Bullmastiffs. I bred the first Bullmastiff to win both the Canadian National Specialty and the American National Specialty in the same year. In my time with the Bullmastiffs, I had many BISS. I published three books on the Bullmastiff breed, the first of which was the first of its kind for 60 years, and the second one was top selling book on Bullmastiffs in the world. My recent new third version completes the trilogy.

I have been involved in breeding and showing Bullmastiffs, Belgian Laekenois, Border Terriers and WH Dachshund in North America, plus earth dog work with Border Terriers and WH Dachshund in Australia, U.S.A. and Canada.

I have judged for over 35 years in many countries including Finland, Sweden, Denmark, Malta, England, Wales, Australia, New Zealand, U.S.A. and of course, Canada. I am a Life Member of the Canadian Kennel Club, member of the Canadian Dog Judges Association, plus a licensed conformation judge in Australia, including my qualification as a Master Earth Dog Judge as a member of the Australian National Kennel Council. For a while I lived in Australia and while there was honoured to be made Patron of the Bullmastiff Club of Western Australia. In my five years in Australia, I judged many times in all of the Australian States and multiple times in New Zealand.

RALLY OBEDIENCE CLASSIFICATIONS

NO DOG MAY BE ENTERED IN BOTH ADVANCED "A" & ADVANCED "B"

NO DOG MAY BE ENTERED IN BOTH EXCELLANT "A" & EXCELLANT "B"

RALLY NOVICE A: Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY NOVICE B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY ADVANCED A: This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY ADVANCED B: This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT A: This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY EXCELLENT B: This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash except the Honour Exercise. All dogs must enter and leave the ring on leash.

NOTE: Miscellaneous breeds entered in Obedience Trials that **DO NOT** have a Certification Number **MAY ONLY COMPETE AT THE NOVICE** level and **MUST** pay the Listing Fee applicable on a daily basis

TRANSITION OBEDIENCE CLASSES

PRE-NOVICE – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes. The P.C.D. is an elective class which is offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles.

NOVICE “C” - This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice ‘C’ exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice ‘C’ Class indefinitely. Scores earned by dogs entered in the Novice ‘C’ Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice ‘C’ are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice ‘C’ class in addition to any of the Official Classes or Unofficial Classes.

NOVICE INTERMEDIATE CLASS - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice ‘C’ and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

PLEASE NOTE: The word ‘trainer’ means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family

NO DOG MAY BE ENTERED IN BOTH NOVICE “A” & NOVICE “B” AT SAME TRIAL

NO DOG MAY BE ENTERED IN BOTH OPEN “A” & OPEN “B” AT SAME TRIAL

NOVICE “A” - This class is open to all dogs, providing the dog has not earned the title of “CD” in ANY COUNTRY. The dog does not have to be CKC or ERN Reg’d to compete in this class. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor ***MUST BE THE OWNER*** or ***A MEMBER OF HIS/HER IMMEDIATE FAMILY*** and ***MUST SHOW THE DOG IN ALL EXERCISES.*** No licensed handler, trainer or any person who has previously exhibited a dog through its “UD” title in Canada or Elsewhere shall be allowed to compete in this class, but **MUST COMPETE IN THE NOVICE “B” CLASS**

NOVICE “B” - This class is open to all dogs that have not earned the title of “CD” in Canada. Dogs in this class may be shown by the owner or any other person. The dog does not have to be CKC or ERN Reg’d to compete this class

OPEN “A” - This class is open to all dogs which have earned the title of “CD” IN CANADA, but have not earned the title of “CDX” in any country. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor ***MUST BE THE OWNER*** or ***A MEMBER OF HIS/HER IMMEDIATE FAMILY*** and ***MUST SHOW THE DOG IN ALL EXERCISES.*** No licensed handler, trainer or any person who has previously exhibited a dog through its “UD” title in Canada or Elsewhere shall be allowed to compete, but **MUST COMPETE IN THE OPEN “B” CLASS.** A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

OPEN “B” - This class is open to all dogs that have earned the title of “CD” in CANADA, and may be shown by the owner or any other person. This dog ***MAY ALSO COMPETE IN THE UTILITY CLASS.*** A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

UTILITY CLASS ‘A’ - This class is open to any dog of any recognized or listed breed which has earned the title of “CDX” but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

UTILITY CLASS ‘B’ - This class is open to any dog of any recognized or listed breed which has earned the title of “CDX” or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered

JUNIOR PUPPY CLASS - This class shall be for any dog **6 months of age and under 9 months of age** on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog **9 months of age and under 12 months of age** on the day of the show

12 to 18 MONTH CLASS- This class shall be for any dog **12 months but under 18 months of age** on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada. (Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. **Note: A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

NON-REGULAR CLASSES

BRACE CLASS - This class shall be for two dogs of the same breed (not necessarily of the same sex)

(Note: effective January 1, 2006 – identical ownership NO LONGER applies)

BABY PUPPY CLASS- This class shall be for any dog **3months of age and under 6 months of age** on the day of the show. The award for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (**This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and PRIOR to Best Brace in Show**)

VETERANS CLASS – Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show (**This class will be held on completion of Best Baby Puppy in Breed, Best Baby Puppy in Group and following Best Baby Puppy in Show**)

*** NEW CKC RULES EFFECTIVE JANUARY 1, 2006 ***

8.2.5 – An error in the class, date of birth or sex of the dog may be amended on the entry form up to ONE hour PRIOR to the start of the show.

8.5.8 – In the case of a judge change (substitute or overload) an exhibitor may enter a dog under the replacement judge providing that the dog is entered in one of the regular classes within the show being held at the same venue by the same club and has been assigned a competition (armband) number. A new entry, along with accompanying entry fees and listing fees (if applicable), will be accepted by the Show Secretary up to ONE hour PRIOR to the opening of the show (see section 3.32, 3.51 & 8.5.4)

8.9.3 – When one or more all-breed and/or Specialty shows are held on the same day, in the same venue, the request for moving class dogs to specials MUST be made a minimum of one hour prior to the scheduled start of the all-breed or Specialty show.

12.3.1 – A Puppy awarded Best Puppy in Group is NOT required to stay for Best Puppy in Show.

Points towards a Grand Championship cannot be gained until a dog completes its Canadian

Championship. The accumulation of points began

January 1, 2013. The dog must compete in the Specials

Only class. Twenty points are needed for the title (the forms are available for download from the CKC website

and it is the responsibility of the owner to keep track and when they reach the 20 points, submit the form to CKC who will verify the wins, and if correct will issue a certificate). In the 20 points there needs to be a minimum of 1 Best of Breed and at least 2 – 2 point wins. The scale of points is the same as for regular championships. A judge will select Best of Breed, Best of Opposite Sex, Select Dog, Select Bitch (the latter 2 will be chosen from the remaining Specials dogs competing, if any in competition). The points are based on the total number of dogs defeated

RULES GOVERNING THESE SHOWS AND TRIALS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY WAS MADE.
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall NOT be included (*effective immediately*) in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

EXTRACTS FROM CKC DOG SHOW RULES

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

8 - ENTRIES and ENTRY FEES

Section 3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) it is not a Miscellaneous breed
- (b) if born in Canada, is eligible for individual registration
- (c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered.

A listing fee of \$8.82 must accompany the entry of a "listed" dog at a show held under these rules.

Section 2.3:

INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made.

Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

Section 8.2:

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 14 - DISQUALIFICATION

Section 1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules

CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.
