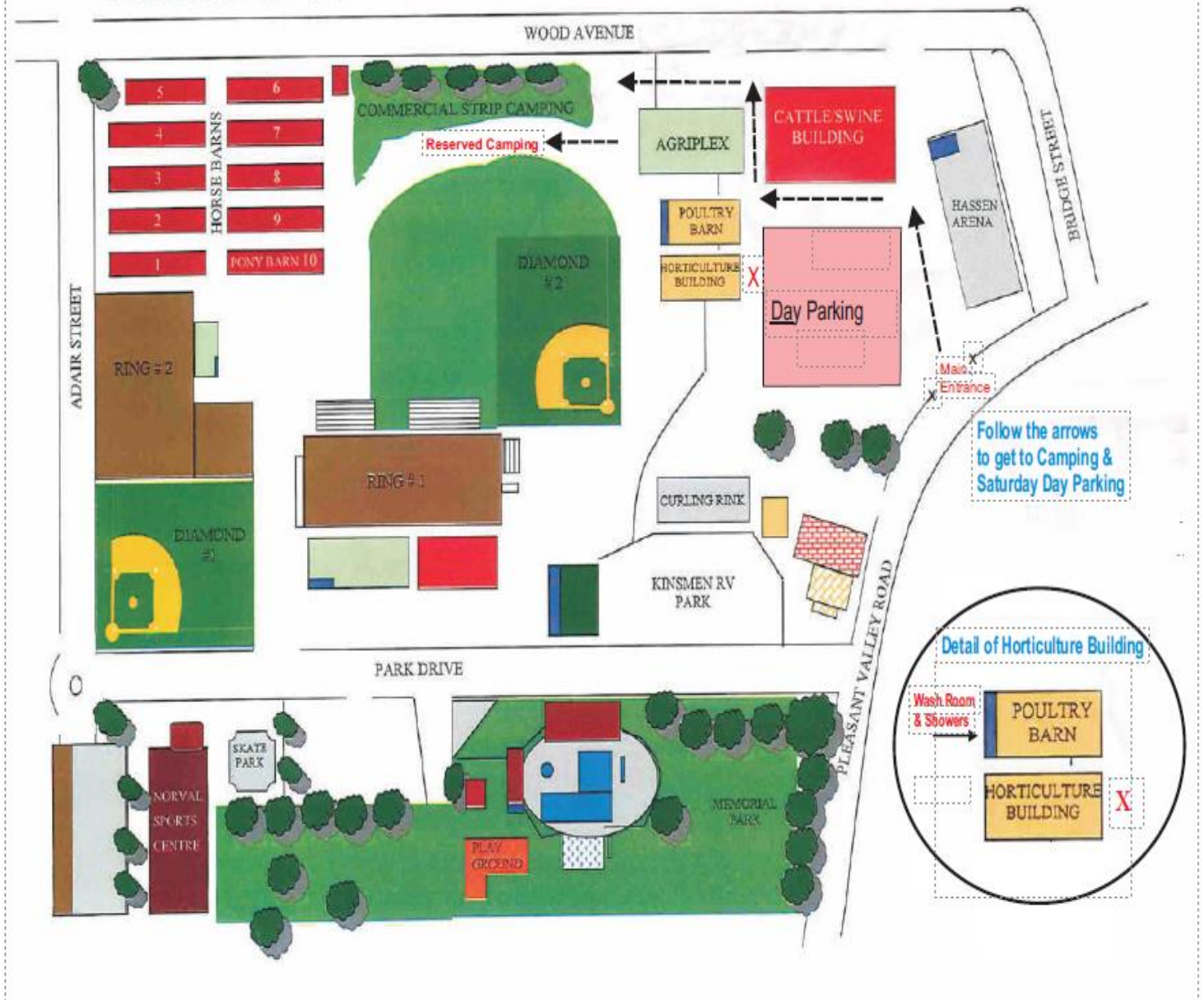

4.4.2 When the advertised limit (if applicable) has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his position on the list. In the event that the entry of a bitch in season is withdrawn after the closing date, it may be substituted with one from the reserve list up to and including the day of the trial. At the club's discretion, if the club is notified in writing after the closing date that an entry other than a bitch in season will be absent from a trial, the entry may be substituted from the reserve list up to 24 hours prior to the trial. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial. Entry fees will be refunded within 10 days following the trial for those on the reserve list who did not participate in the trial.

**JUNIOR OBEDIENCE COMPETITION – Entries will be taken up to 10:30 am on Saturday.**
