#### General Information

- 1. Location of Dignified Dogs is Unit K, 9827 Horton Road SW, Calgary, AB. Parking is available on the East and West side of the building. There is also limited parking available on the east side of Horton Road SW. Please respect the no parking signs of other businesses next to the venue.
- 2. The show building will be open one hour prior to commencement of judging. **Judging starts at 8:30 AM.** If you attend the match on February 15th, you will be able to leave your equipment in the building overnight.
- ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES. If not competing, the dog must wear a collar and be on a leash of a maximum length of six (6) feet or be appropriately confined in the benching area. NO FLEXI LEASHES WITHIN THE BUILDING.
- 4. Benching will take place upstairs. Only a limited number of spaces will be available on the main floor and these will be offered to exhibitors who would have difficulty benching upstairs. There will be ABSOLUTELY NO benching at ringside.
- 5. EXHIBITORS PLEASE NOTE: CKC Obedience Trial Rules and Regulations (Chapter 3, Section 3.6.1) "A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out."
- 6. Exhibitors must abide by errors made in entering their dogs, regardless of how, or by whom, the entry was made.
- 7. The Show Precincts are defined as "DIGNIFIED DOGS".
- 8. Dogs must be exercised in designated areas ONLY.
- 9. All empty rings are to be kept free of dogs.
- 10. The Rottweiler Club of Canada, its members and volunteers will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- 11. The Trial Superintendent has the authority to expel any dogs deemed to be a danger to other dogs or people. There will be no refund for dogs that are expelled.
- 12. **Indoor Shoes:** Just a reminder to everyone entered in the trial, to bring indoor shoes, as it is most likely the weather will be wet. OUTDOOR SHOES ARE NOT PERMITTED WITHIN THE RINGS.
