### **MRS FAYE STRAUSS**

Faye Strauss established Sherluck Dobermans in 1973 and bred 100+ AKC Champions to date. As a handler, Faye finished over 70 Doberman Pinschers and garnered numerous Best in Show and Group wins. Faye also handled 15 other breeds.



As an AKC judge, Faye judges the Working and Non Sporting Groups, nine Sporting breeds, two herding and two hound breeds as well as Best in Show and Junior Showmanship.

It was a great honor for her to judge the US Doberman national four times, including Best Of Breed classes two times and the United Doberman Club national two times. She has judged in many countries around the world including China, Taiwan, Trinidad, and Canada. Judging the Doberman national in Australia, Brazil, Argentina, Mexico, and the Philippines were great honors. She has also judged for the Westminster Kennel Club show in NYC. She also judged the Greater Swiss Mountain Dog national, the Top 20 for the Newfoundland, Doberman and Basenji Clubs of America.

In 1995, Faye founded Sherluck MultiMedia that produced CD Breed Studies on 15 breeds including Boxers. Faye's book on 'The Doberman Pinscher' (TFH publisher) won Breed Book of the Year in 1998. She is also the AKC Gazette columnist for the Doberman Pinscher Club of America. Faye is on the board of the Doberman pinscher Club of America, and Judges Education Committee chairperson of the Doberman Pinscher Club of America. She is currently President of the Mount Rainier Working Dog Club and Puget Sound Doberman Pinscher Club. She is also a member of the Seattle Kennel Club.

### MRS JUDY WATSON

Residing in Calgary, Alberta, Judy has been involved with Siberian Huskies since 1979 under the prefix "Suminka" and has bred more than 20 CKC Champions earning Multiple Group placements in Conformation and several others with Obedience Titles.

Marion Postgate is a CKC Licensed judge of the Toy and Non-Sporting groups and all obedience and rally classes, judging in both Canada and the US. She started in dogs in Juniors, and showed a variety of toy breeds, plus a Sheltie, in conformation and obedience. 

**RALLY NOVICE A:** Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. **RALLY NOVICE B:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY ADVANCED A:** This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. All dogs must enter and leave the ring on leash. **RALLY EXCELLENT A:** This class shall be for dogs that have won the Rally Advanced (R. A.) title, but have not won the Rally Excellent (R. E.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY EXCELLENT B:** This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash except the Honour Exercise. All dogs must enter and leave the ring on leash.

### **OBEDIENCE CLASSIFICATIONS**

NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & "B" AT SAME TRIAL NO DOG MAY BE ENTERED IN BOTH OPEN "A" & "B" AT SAME TRIAL

NOVICE "A" - This class is open to all dogs, providing the dog has not earned the title of "CD" in ANY COUNTRY. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL EXERCISES. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete in this class, but MUST COMPETE IN NOVICE "B" CLASS **NOVICE "B"** - This class is open to all dogs, which have not earned the title of "CD", and may be shown by the owner or any other person. The dog may not necessarily be CKC or ERN Reg'd to compete in this class OPEN "A" - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL EXERCISES. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but MUST COMPETE IN THE OPEN

"B" CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

**<u>OPEN "B"</u>** - This class is open to all dogs, which have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog **MAY ALSO COMPETE IN THE UTILITY CLASS**. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

<u>UTILITY CLASS 'A'</u> - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

**UTILITY CLASS 'B'** - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

### **OBEDIENCE CLASSES: Unofficial**

Refer to Section 15 of the O.T.R.&R. The rules are paraphrased below. The following classes are offered at these Trials:

<u>VETERAN'S CLASS</u>-is open to dogs that have an obedience title and are 7 years and older. Dogs entered in this class must also be entered in any Regular class or for Exhibition Only.

### TRANSITION OBEDIENCE CLASSES

**PRE-NOVICE** – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes.

**NOVICE "C"** – This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes.

**NOVICE INTERMEDIATE CLASS** – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

### NON-REGULAR CLASSES

**BRACE CLASS** - This class shall be for two dogs of the same breed (not necessarily of the same sex)

**STUD DOG CLASS** – This class shall be comprised of the Stud Dog and 2 or more of his get. All dogs comprising the get need not be the property of the same exhibitor. Get must be entered in a regular class.

**BROOD BITCH CLASS** – This class shall be comprised of the Brood Bitch and 2 or more of her progeny. All dogs comprising the progeny need not be the property of the same exhibitor. Progeny must be entered in a regular class.

**PARADE OF CHAMPIONS**– This class shall be for all Boxers who: hold a CKC or AKC Championship and/or hold a CKC or AKC performance title Dogs entered in the Parade MUST be entered in a Regular class or for Exhibition only, spayed and neutered dogs may be entered in the parade. The parade will be held after the completion of Best of Breed judging. *Please include a short resume of your dog, limited to 50 words or less for publication in the catalogue.*

### DOG SHOW CLASS INFORMATION

*JUNIOR PUPPY CLASS* - This class shall be for any dog 6 months of age and under 9 months of age on the day of this Specialty

**SENIOR PUPPY CLASS** - This class shall be for any dog 9 months of age and under 12 months of age on the day of this Specialty

**12 to 15 Months Class** – This class shall be for dogs at least 12 mos. of age on the day of this Specialty and under 15 mos. on the day of this Specialty

**15 to 18 Months Class** – This class shall be for dogs at least 15 mos. of age on the day of this Specialty and under 18 mos. on the day of this Specialty

**CANADIAN BRED CLASS** - This class shall be for any dog born in Canada. (Champions of any country excluded)

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring owner/breeder. The handler <u>**MUST</u>** be the owner/co-owner <u>**AND**</u> breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards</u>

OPEN BRINDLE CLASS - This class shall be for all dogs of the brindle colour

OPEN FAWN CLASS - This class shall be for all dogs of the fawn colour

VETERANS CLASS – This class shall be for dogs 7 years of age and over on the day of this Specialty. (This class will be divided into 3 age divisions – 7 to 9 yrs, 10 & 11 yrs and 12+ yrs. Winners of each class will carry through to compete for Best of Breed)

**SPECIALS ONLY CLASS** - This class shall be for Champions of record at the time of closing of entries for this Specialty. <u>Note</u>: A Listed dog <u>MAY</u> be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class <u>MUST</u> be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE FIRST SHOW. Listing Fees <u>WILL NOT</u> be refunded

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class may not compete in any Regular class but may enter and compete in Non-Regular classes and/or Parades
