In payment of entry fees, the tendering of NSF cheques shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Fax entries and/or credit card payment will be accepted when accompanied by authorized VISA or MASTERCARD credit card number, expiry date and cardholder's name. 10% of total fee will be added for FAX/Credit Card entries. Customers whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted. There will be no refund on overpayments or duplicate entries. Please mail entries early to ensure that they are received before the closing date

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing* 1 2 3 to 5 6 to 9 10 to 12 13 or more Points Allocated* 0 1 2 3 4 5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above.

The system provides for additional points if a dog awarded winners also places in the Group as listed hereunder. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

Sweepstakes Prize Monies (Puppy and Veteran)

25% of total entry fees will be retained by the Club for expenses

Best in Sweepstakes......10% of total purse

The remainder will be divided as follows:

Undistributed funds revert to the Club Classes: Juvenile & Veterans Sweeps

6-9 month, 9-12 month, 12-18 month

7-9 years, 9+ years

All entries in the Puppy Sweepstakes must also be entered in one or more of the Regular Classes at the regular entry fee. Veteran dogs do NOT have to be entered in a Regular Class. Classes will be divided by sex for Juvenile and Veterans. Each breed will have its own sweepstakes classes, the winners of each breed to compete for Best in TriArctic sweeps.

REGULAR CLASSES

The following classes will be provided, divided by sex.

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

12 - 18 MONTH 12 months & under 18 months on the day of the show

CANADIAN BRED - Dogs born in Canada. Champions of any country are excluded.

BRED BY EXHIBITOR – Dogs owned and handled in the ring by the breeder. The handler must be the owner/co-owner and breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

OPEN CLASS - shall be for all Dogs.

VETERANS - open to all dogs over 7 years of age and older on the day of the Specialty. The winners of the Veterans Male & Female classes will not compete for Championship points but go directly into the Best of Breed competition. Veteran dogs may be neutered or spayed.

SPECIALS ONLY - This class will NOT be divided by sex. A dog may be entered for "Specials Only" and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. Should a dog entered for Specials Only place in its group at the show then all awards the dog earned at the show will be canceled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT allowed

* BABY PUPPY class will be offered by the Edmonton Samoyed Club ONLY Rosette and prize will be offered

NON-REGULAR CLASSES

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes.

STUD DOG & GET - The name of the Stud Dog must be indicated on the entry form, the name of the get must also be on the entry form. The entry will consist of the dog and two of his progeny. Entry in this class need not be the property of the same owner although ALL must be entered in regular classes or Specials Only or Exhibition Only

BROOD BITCH & PROGENY - The name of the Bitch must be indicated on the entry form, the name of the get must also be on the entry form. The entry will consist of the bitch and two of her progeny. Entry in this class need not be the property of the same owner although ALL must be entered in regular classes or Specials Only or Exhibition Only

BRACE CLASS.... This class shall be for two dogs of the same breed (not necessarily of the same sex)

Unofficial Classes

* Working Dog Class and Sled Dog Class: Offered by the Siberian Husky Club of Canada ONLY WD - Working Dog Class

WDX - Working Dog Excellent Class - classes to be offered for dogs who have obtained their SHCC. A copy of the title certificate must be faxed or provided to the Show Secretary before the dog can enter the ring. Males and females will be judged together. Ribbons will be awarded for 1st to 4th in each class. The two winners (Best WD and WDX) will compete for Best Overall Working Dog.

Sled Dog Class: SD, SDX and SDU

SD - Sled Dog Class

SDX - Sled Dog Excellent Calass

SDU - Sled Dog Unlimited Class

Proof of title must be faxed or provided to the Show Secretary before the dog can enter the ring. entries. Males and females will be judged together. The winner of each class compete for Best Overall Sled Dog.

Each entrant for these Unofficial Classes must be entered in one of Official Classes in the Specialty or Exhibition Only.

JUNIOR SHOWMANSHIP COMPETITION - Conformation - Under CKC Rules

Conformation Classes offered: Pee-Wee (4-7 years non-competitive) Junior (Novice-Intermediate-Open) Senior (Novice-Intermediate-Open)

Entries: Fee \$2.00. Entries will be taken on Saturday

GENERAL RULES GOVERNING THESE SHOWS

- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC Rules.
- 2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors patrons, or equipment.
- 4. A Judge or any person participating in any capacity at a Dog Show held under C.K.C. rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.

- 6. DOGS MUST BE READY FOR JUDGING. The club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. The ring shall not be held up waiting for exhibitors or handlers.
- 7. The owner of a dog entered in these shows is entirely responsible for any error in entering his dog, regardless of how or by whom the entry was made.
- 8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied with a fee set by CKC which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned by a dog shown in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
- 9. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring.
- 10. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.
- 11. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from completion by action of the Show Committee.
