Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.

Rally Obedience Judging is based on 15 dogs/hour plus a 10 min walk-through time per class.

✓ Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies.

✓ It is the exhibitor's responsibility to know the rules pertaining to the trials.

✓ The precincts of the Trials will be the building and its surroundings.

√ No prong or spike collars permitted on site.

✓ All exhibitors will be responsible for the clean-up of their own dogs anywhere on the trial site and surrounding areas.

✓ Venue will be open at 7:00 am on Saturday and Sunday. Since the trials are full there will be no Day of Entries.

Exhibitors will enter the venue at the front door where they will collect their armband and catalogue (if ordered).

This is the only Entrance that will be used during the Trials. The side entrance will be closed.

To manage congestion in the staging area, it is recommended that you keep your dogs leashed and under control.

There will be a marked practice area set up in the staging room for one exhibitor at a time. Please be considerate and make this space available to the next competitor if they wish to use it.



Spectators are welcome in the trialing area. Please respect the Competitor in the ring.



As in the past, we will provide a warm-up space in the trialing area for the next dog only waiting to compete.

There will be no crating available on the blue floor of the Trialing area.

TRIBUTE TO DON WALLACE

Don Wallace was an integral part of the Dartmouth Kennel Club for over forty years. He served our Club as President, Vice President, Show Chair, Show Superintendent and most recently and for several years, as Treasurer. His role as Treasurer extended to the fall of 2022, well into his 90th year.

Don will be remembered for his dedication to our club and his passion for its survival. He believed rules were made to be followed and doing what was right was never out of style. His honesty and integrity carried over into his judging career. Don was a CKC Obedience judge, Obedience Rally Judge and a Conformation judge for over 22 years. He was a founding member and Past President of the Canadian Association of Obedience Trial Judges and member of the Canada Dog Judges Association since it was established in 1997. He was a member of the Canadian Collie & Shetland Sheepdog Association for over 35 years. He bred Shetland Sheepdogs, and along with his wife, Dot, and children, Kathleen and George, he competed successfully in both Obedience and Conformation. He was a member of that select group of people to achieve a BIS and HIT on the same day.

Don's commitment to purebred dogs was recognized in 2014 when he was elected as Honourary Chair of the Canadian Kennel Club. This was a well-deserved honour and a proud moment for Don.

The Dartmouth Kennel Club was better for having Don as a guiding force and he is missed. We are proud to dedicate these Trials to his memory.



Reminders Pertaining to the Venue



- No outdoor shoes in the Trialing area
- No food or drink (water only) in the Trialing area (blue floor)
- No smoking on the premises
- Parking only on the side of the venue building and in the front parking lot
- No parking past the second side door as it is not owned by Ace It
- No exercising dogs on the opposite side of the street, private area
