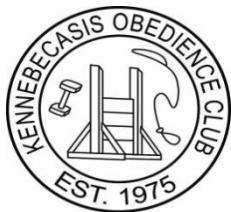

No post dated cheques will be accepted. A post dated cheque is one that is dated after the receipt of the entry. **All N.S.F. cheques will be subject to a charge of \$20.00.** N.S.F. cheques are considered non-payment of entry fee and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.

Attention USA Exhibitors: Please note that due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, **however**, they are to be payable in Canadian Funds. If you send a cheque in US Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable In Canadian Funds" or "At Par", they will NOT be cleared by the banks. To simplify the process, we are suggesting that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You!

NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a "non member" of the Canadian Kennel Club.


The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

In order for the title to be awarded, the non member will have a choice to either

become a CKC member or pay the non member participation fee. Failure to comply within

30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

The fee applies only to dogs wholly owned by non member residents of Canada and is not applicable to Canadian Kennel Club members.

TEMPORARY COMPETITION NUMBER (TCN) - * Effective March 2, 2020

A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered.

Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN).

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly.

Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. Dogs may still enter CKC events until without a registration number or ERN until March 2, 2020 by marking TCN on the entry form (or Listed if it is an older entry form). An email address is required on the entry form in this case. Before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account. * If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, there is no need to apply for a TCN. The CKC will update its records accordingly.

OBEDIENCE TRIAL AND RALLY-OBEDIENCE TRIAL RULES AND REGULATIONS

A copy of the CKC rules pertaining to Obedience Trial and Rally-Obedience Trials is available from the Canadian Kennel Club. Each exhibitor is responsible for knowing and complying with the rules of the CKC regarding their event.

The Dog Show Rules Section 4.1.6 states "no person may approach a judge, either directly or otherwise, orally or in writing to favour his entry. Disciplinary action may be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act".

JUDGING SCHEDULE

Judging schedules and Receipt of Entry and Arm Band Numbers will be emailed to all entrants. Schedule will be posted on the '[Canuck Dog Website](http://www.canuckdogs.com)'.

Driving Instructions to the Show Site will be found on the Judging Schedule.

GENERAL INFORMATION

1. No entries may be accepted, altered, cancelled or substituted after the official closing date and time for entries except as provided for in the rules.
2. BITCHES IN SEASON: Refund of entry will be made on bitches that come in season after entries close. Request in writing must be submitted to the Trial Secretary with a certificate from a veterinarian on or before the day of the trial.
3. In Canada, an obedience or rally title can be earned with three (3) qualifying scores under two (2) different judges.
4. Exhibitors should note that the CKC does not confer a title on any dog until it is registered with the CKC – full registration, ERN, CCN or PEN.
5. A dog which has earned its CD title in the USA or any foreign country is not eligible for entry in the Novice A class. A dog which has earned its CDX in the USA or any foreign country is not eligible for entry in the Open A class. Such dogs must be entered in the respective B classes. Licensed handlers, trainers and persons who have previously exhibited a dog through its UD in Canada or elsewhere are not eligible for entry in the A classes.
6. Exhibitors must abide by any errors made in entering their dogs, regardless of how or who made the errors.
7. It is the responsibility of the exhibitor to have the dog at ringside when the dog's class is scheduled for judging.
8. If entering a dog in Open or Utility and Rally Advanced or Excellent PLEASE MARK JUMP HEIGHTS ON ENTRY FORMS.
9. The Trial Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for or assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
10. The precincts of the trials shall be 3 feet around the ring.
11. If because of riot, civil disturbance or any other acts beyond the control of the club, it is impossible to open or close trials, no refund of entries will be made.
12. Section 20.7 Obedience Trial & Rally Obedience Trial Rules and Regulations
It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
13. It will be the responsibility of the exhibitor to ensure that any electronic submission reaches the proper authority or recipient with the times & limits as regulated in the CKC rules & regulations. Sent fax receipts and/or copies of sent emails will not be taken as evidence of receipt by recipients.
14. Ring dimension for rally trial is 40' x 50'.

PLEASE CLEAN UP AFTER YOUR DOG ON GROUNDS, AT YOUR SET UP SITE AND ALSO AT YOUR HOTEL, MOTEL OR CAMPGROUND

COVID-19 - Please Read!

Note: These are subject to change depending on restrictions at the time of the shows and trials.

- We will be observing provincial and regional guidelines regarding travel into and out of our zone, as well as safety protocols with regards to COVID.
- Every person entering the property will be screened and will be refused entry if you are violating any provincial guideline regarding travel or if you display symptoms with no refund of entries given.
- If you are in doubt, check with the province by calling 1-833-948-2800
- If the New Brunswick border remains closed the weekend of our shows "the show will go on".

REFUND POLICY

- If, due to COVID, these Shows are not able to be held; refunds will be issued to exhibitors - MINUS 20%. While all efforts will be taken to expedite refunds, they may take up to 14 days (depending on volume & other work commitments).
- If because of; an act of God, riot, civil disturbance, extreme weather event, governmental orders, regulations, or decree, or other acts or circumstances beyond the control of the CDC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.

THERE WILL BE A ZERO TOLERANCE POLICY ON COVID-19 VIOLATIONS, INCLUDING NOT WEARING A MASK OR NOT SOCIAL DISTANCING.

- A Waiver will be emailed out along with the judging schedule. You will be required to print off enough waivers so that every individual traveling with you has their own waiver (including minors).
- The waiver must be signed by all Club Members, Judges, Ring Stewards, Exhibitors, Owners, Handlers, Breeders, Assistants, Volunteers, Commissionaire, and Family Members, Friends etc.
- Contact tracing information must be provided for all who are on site including minors (name & phone number).
- Once you have handed in the Waiver(s) at check in on the show grounds a bracelet will be issued to you. If you misplace the bracelet you will need to fill out a separate waiver in order to receive another bracelet. **A bracelet must be worn at all times when on the show grounds. If you do not have a bracelet on, you will be asked to leave the show grounds.
- Everyone must wear masks correctly over mouth and nose in the rings during judging (Exhibitors, Judges, Stewards). They will also be required anywhere on the property where social distancing (2 meters) cannot be maintained. Social Distancing (2 meters) is mandatory in the rings, under the tents, adjacent ring areas, at the Show Secretary Table/Set-up, at the Photographers booth.
- Each ring will have an Entrance, and an Exit and Social Distancing Markers. Exhibitors will pick up their ribbons as they exit the ring, **NO RECYCLING** of ribbons.
- Exhibitors are encouraged to return to their set up after they have exhibited their dog. Parking will be directed, and space is not an issue. Generators are permitted in the parking area, as are personal ex-pens, grooming tables, pop-up tents, portable picnic tables etc.

TRAILER REGISTRATION

1. Trailer and/or RV space is available for up to 20 units. Book your space early.
2. There will be a Flat Fee of \$50.00 for the weekend. **ELECTRIC HOOK UPS AND WATER WILL NOT BE AVAILABLE. YOUR SPACE MUST BE PREPAID.** Please send funds with form below to the Show Secretary.
3. No parking of Trailers/RV except in designated areas. Anyone violating this rule will be removed and will not be permitted to exhibit in the NBKC shows.
4. No emptying of tanks in the field or in the parking lot.
5. PLEASE NOTE: Trailer/RV space must be reserved by Show closing date August 09, 2021. **NO late arrivals will be accepted.**
