DIRECTIONS

Driving Instructions:

From Toronto: Hwy. 400 north approx. 82 km to Hwy. 11 North. Proceed north on Hwy. 11 approx. 195 km to McFadden Line/Hwy. 522 (exit 301). Proceed north on McFadden Line (Hwy. 522) approx. 2 km to Main St. (Trout Creek). Turn left on Main St. (Hwy. 522) and proceed west to arena on the left.

From Sudbury: Hwy. 17 east approx. 120 km to Hwy. 11 South. Proceed south on Hwy. 11 approx. 38 km to Hwy. 522B (exit 366). Turn left on Hemlock Rd. (Hwy. 522B) and proceed south approx. 1.75 km to Main St. (Trout Creek). Turn right on Main St. (Hwy. 522) and proceed west to arena on the left.
