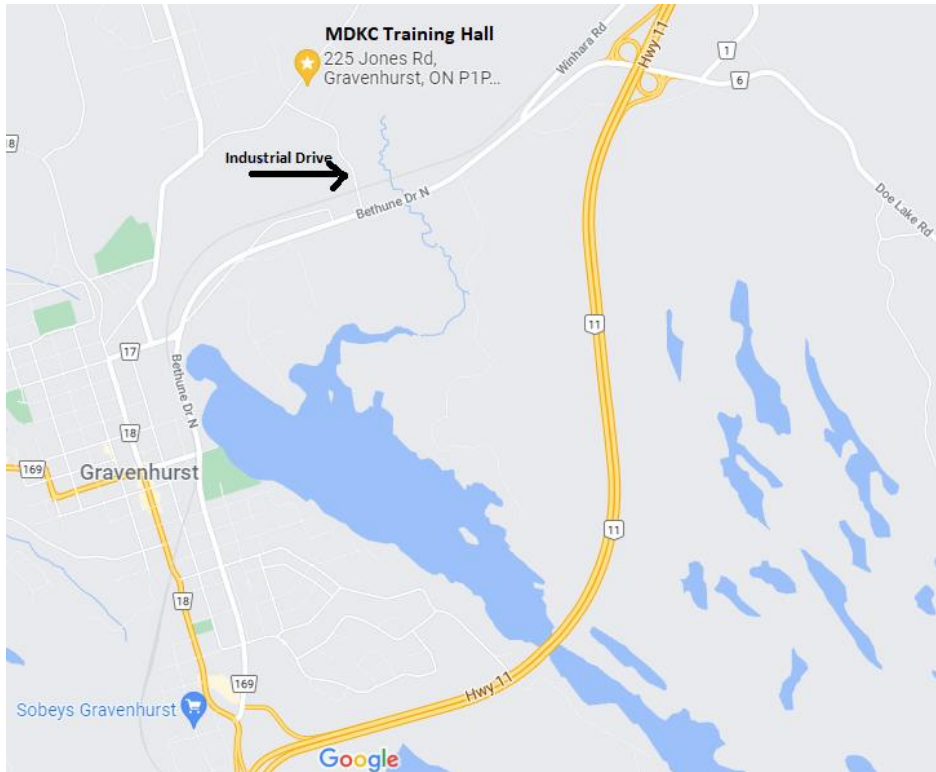

OBEDIENCE TRIAL RULES AND REGULATIONS

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club

Chapter 19 – Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

6.5.2 **Bitches in Season** are not permitted to compete. When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial, must be submitted to the trial secretary on or before the date of the trial. A refund of the entry fee, service charge and listing fee will be given

GENERAL INFORMATION

1. Muskoka District Kennel Club will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume any liabilities in the event of an accident or other mishap, however caused, to either dog or exhibitor. A dog shall not be touched without the permission of the owner or agent.
2. Only dogs entered in Trials will be permitted in the Trial Building.
3. Trial start times will be indicated on the judging schedule.
4. Trial Precincts shall be the MDKC Building
5. Rally Ring size shall be 35' x 72'

EVENT REGISTRATION NUMBER

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Please contact CKC for further info.

NON-MEMBER PARTICIPATION FEE - Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

LIMITED ENTRY TRIALS

Entry forms **must be complete** and submitted with the correct fees.

WHICH CLASS TO ENTER:

Rally Obedience

Novice A:

- If your dog has not have earned a Rally Novice title, or any CKC obedience title other than PCD.
- If you have not titled any dog through to a CDX in obedience
- If you own, co-own or are a member of the immediate family of the owner.

Novice B:

- If you or your dog do not meet the criteria for Novice A
- If your dog has not earned a qualifying score in Rally Advanced.

Obedience

Novice A:

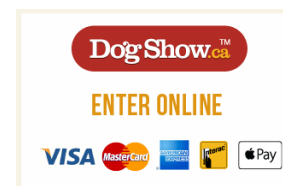
- If your dog has not have earned a CD title.
- If you have not titled any dog through to a CDX in obedience
- If you own, co-own or are a member of the immediate family of the owner.
- You can only enter one dog in this class.

Novice B:

- If you or your dog do not meet the criteria for Novice A
- If your dog has not earned a CD
- You may enter more than one dog in this class. You must have an additional handler for each dog when judged in the group exercises.

Novice C:

- If your dog has already earned a CD
- Scores from this class are not eligible for HIT and do not qualify for any title.



COVID19 Waiver

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly via respiratory droplets and aerosols. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at this event or participation in this event programming ("Claims"). On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless MDKC, its employees, agents, and representatives of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the MDKC, its employees, officiating judges, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any MDKC program or event. In consideration for being allowed to attend, I agree to indemnify and hold harmless the MDKC, and the CKC from all liability or claims of any nature by myself, my guests and family members. COVID19 Safety Measures

Please be aware:

- the MDKC Trials will be held in the Simcoe Muskoka District Health unit, and we will be required to follow any additional restrictions enacted by that Health unit in addition to those required by the province of Ontario.
- Guidelines and restrictions around COVID-19 are prone to changing frequently and rapidly. It is your responsibility to be aware of the current guidelines and restrictions and to follow them at all times. If you have questions, please ask!
- The safety measures below are subject to change based on information received from or decisions made by federal, provincial, and local governments and federal, provincial and local health agencies and there may be additional measures added by the time of the trials.

COVID Safety Measures

- You must not attend if you have any symptoms of COVID-19, are supposed to be self-isolating/quarantining, have been out of the country in the past 14 days or have come into contact with someone that tested positive for COVID-19 or was symptomatic for COVID-19 in the past 14 days.
- You must submit a completed COVID-19 waiver prior to attending.
- Our event is required to follow provincial regulations requiring participants present proof of 2 COVID vaccinations completed at least 14 days prior to your arrival at the trial. Please make sure you have the necessary documentation with you when you arrive.
 - a) Proof of both COVID vaccinations administered at least 14 days prior to your arrival. OR if medically exempt, your doctor's note.
 - b) Photo ID (i.e. driver's licence or health cards)
 - c) Also, a signed copy of your COVID waiver for our files.Without this documentation, we cannot allow you to enter the building to compete.
- There will be no food available on site.
- There will be no indoor crating, you must crate out of your vehicle.
- There will be no spectating.
- There will be no day of entries and no day of move ups. We will take move ups on Saturday for the trials on Sunday.
- You must wear a snug fitting mask that covers your nose, mouth and chin at any time that you are in the MDKC building, or any time you cannot maintain 6 feet of distance from people not in your household.
- You must maintain 6 feet of distance from people not in your household at all times, unless it is unavoidable for a brief moment.
- There will be hand sanitizer available, please make use of it frequently.
