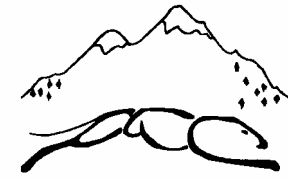

### ADDITIONAL CONDITIONS

- Stakes will be split if the entry is 24 or more hounds at the time of Roll Call.
- Hounds will be run twice, in braces or trios (except single dog entries) unless dismissed, excused or declared ineligible.
- Bitches in season and lame hounds will be excused and their entry fee refunded, provided notice is given prior to or during roll call.
- Hounds not present at roll call shall be scratched with no refund of entry. No Exceptions.
- All handlers must use a slip lead when releasing their hounds. A **STANDING START** will be used on Tally-Ho.
- Muzzles and catch collars may be used at the handlers' discretion. Leg wrappings must be a neutral color to comply with CKC rules.
- There will be a \$5 fine for dogs found loose on coursing field after roll call and before completing Best in Field. There will be a \$20 fine for anyone caught not cleaning up after their hound.
- Bring your own water, and shade.

**Irish Wolfhound Booster** Irish Wolfhound Club of Canada Mid-Western Branch is pleased to offer special prizes to all placements in Irish Wolfhounds.

In honor of our 30th Anniversary of Lure Coursing and counting, FGC has created a **Rachelle Descent Founder's Trophy** to be awarded to the hound achieving top overall aggregate for the year. Your hound must compete at **all** FGC trials throughout the year to be eligible for this award. **For 2011 this will be seven events.** The trophy will be awarded at this trial.

### STAKES OFFERED:

**OPEN** All hounds 1 year & older on day of trial, including Field Champions of record.

**MIXED** Combines breeds with entries of three or less with agreement of all owners.

**BEST IN FIELD** For all Best of Breed winners & 1<sup>st</sup> from Mixed Stake

**BREEDER STAKE** Open to any 2 hounds in the official classes bred by the same person(s).

**KENNEL STAKE** Open to any 2 hounds in the official classes owned & kenneled by the same person(s).

**\*NOTE: Breeder & kennel stakes combinations must be declared prior to Roll Call.**

### PLACEMENTS AND AWARDS

Chapter 7, Section 1: Championship points are awarded to regular stakes only on the following basis:

**1st Place:** 4 x number of hounds competing in stake with a max. of 40 points

**2nd Place:** 3 x number of hounds competing in stake with a max. of 30 points

**3rd Place:** 2 x number of hounds competing in stake with a max. of 20 points

**4th Place:** 1 x number of hounds competing in stake with a max. of 10 points

**NBQ:** Next Best Qualifying Score - no points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been **excused** in the preliminary run, that hound shall not count as having been in competition.

### ELIGIBILITY TO ENTER THESE TRIALS

Open to any Afghan, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Pharaoh Hound, Saluki, Scottish Deerhound, Whippet, Irish Wolfhound. All entrants must be registered or eligible for registration with the CKC. Altered and neutered dogs may compete. **DOGS PRESENTLY DISQUALIFIED UNDER ASFA, CSFA, AKC OR CKC RULES ARE NOT ELIGIBLE. HOUNDS MUST PRE-QUALIFY BEFORE ENTERING THEIR FIRST TRIAL IN CANADA. IF APPLICABLE, PLEASE PROVIDE PROPER CERTIFICATION WITH YOUR ENTRY.**

**It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**

### NON CKC MEMBER PARTICIPATION FEE—Canadian Residents Only

Effective Jan 1, 2011, the CKC instituted a Non-Member Participation fee for all Canadian residents who participate in a CKC event but are not CKC members. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or pay the non-member participation fee.

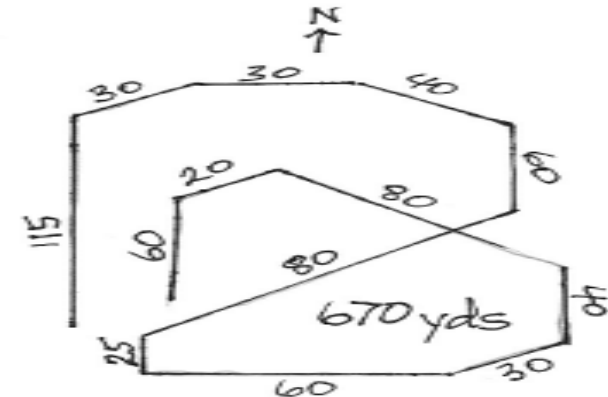
Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non-members who reside in Canada and does not apply to U.S. exhibitors, or to CKC members or dogs co-owned with a CKC member.

**Running Order: GH, IB, IW, SD, Mixed, AF, BJ, BZ, IG, PH, SL, WH**

**NOTE:** Should field or weather conditions warrant, the Club reserves the right to alter this plan. A Drag lure machine with white plastic lure will be used on all courses.

**FIELD CONDITIONS:** The field is across the road from the Evelyn Kenney Kennel and Obedience Club show grounds and is a flat soccer field. If not removed, the soccer nets will be wrapped in snow fence. **There is no on field parking. Benching will be permitted at the edge of the field.
