- 2. Dogs MUST be kept on leash in the venue and precinct areas except when being judged.

<u>The venue</u> is defined as the confines of the Arena building and <u>the precinct</u> is the enclosed rink area where the rings are situated.

- 3. The Mountain City Obedience Club will use all reasonable care to guarantee the safety of dogs and exhibitors, but will not be responsible for the loss or injury, however caused, to any dogs, exhibitors or property.
- 4. Only those dogs registered individually with the CKC or eligible for individual registration may be entered at these trials.

#### Rule changes for Obedience - effective January 1, 2012

As there have been numerous changes in the rules and regulations, it is the responsibility of each exhibitor to familiarize themselves with these changes. Rule books may be purchased from the CKC order desk.

Entries will not be accepted without fees. Entries MAY NOT be changed and fees ARE NOT refundable after the closing date.

<u>U.S. EXHIBITORS</u> It is recommended that you purchase a Postal Money Order or Bank Draft in CANADIAN FUNDS, however, if you wish, you may pay in U.S. FUNDS at the above rates. Any entry with a cheque made "Payable in Canadian Funds" will have to be rejected.

IMPORTATION OF DOGS A dog may be brought into Canada from U.S.at any customs port of entry if it is accompanied by a certificate/receipt that clearly identifies the animal and shows that the animal has been vaccinated against rabies during the three years preceding importation.

Please note that upon returning to the U.S., you must present a rabies certificate which is dated between 30 days and one year prior to the date of leaving Canada. This is a U.S. government regulation.

11. <u>LISTING FEES</u> A CKC listing fee of \$8.75 per dog for each entry per trial must be included with your entry if you are not able to show on your entry form the CKC individual registration number or an event registration number (ERN).

The CKC DOES NOT confer a title on any dog until it is registered in the CKC records. No dog is eligible to compete in the Open class unless it is individually registered with The Canadian Kennel Club.

#### 12. CLOSING DATE FOR ENTRIES MAY 10, 2013 or

when the judge's assignment has been reached - 7 hours of judging based on the formula of 9 Pre-Novice, 8 Novice, 7 Open and 6 Utility dogs/hr. in Obedience and 35 dogs per trial in Rally Obedience whichever comes first. A "Reserve List" will be maintained, according to The Canadian Kennel Club regulations.

13. <u>ENTRY FORMS</u> must be complete in every respect and exhibitors must abide by any errors made in entering their dogs regardless of how, or by whom the entry was made.

ONLY AN OFFICIAL CKC ENTRY FORM MAY BE USED The Club reserves the right to refuse entries subject to CKC rules.

All entries will be acknowledged, accompanied by a judging schedule.
