THE BUILDING WILL OPEN EACH DAY AT 7:00 AM, AT COLISEUM CONCOURSE DOORS #17 & #22 AT THE BACK OF THE BUILDING OFF KILLAM DRIVE (SEE DIAGRAM), AND WILL CLOSE 1 HOUR AFTER BEST IN SHOW JUDGING OR OBEDIENCE JUDGING.

NO DOGS ARE TO BE LEFT IN THE BUILDING OVERNIGHT.

THE COLISEUM CONCOURSE WILL BE OPEN FOR SET-UP NO EARLIER THAN 2:00 PM ON THURSDAY MAY 25th AND WILL CLOSE AT 8:00 PM.

Unfortunately, **NO CAFETERIA IS AVAILABLE**. Numerous food outlets are within 3 - 5 minutes on Killam Drive and Mountain Road.

The Moncton Kennel Club and the Moncton Coliseum / Agrena Complex will not be responsible for any belongings left in the building or outdoors. Please do not leave valuables unattended.

SPECTATORS are permitted on FRIDAY at 12:00 to 4:00, SATURDAY & SUNDAY at 10:00 to 3:00, FOR A FEE, THROUGH THE FRONT ENTRANCE OF THE COLISEUM.

Chairs will be limited and must remain in the Coliseum with the rings, not moved to the Concourse.

CLEANUP: All exhibitors will be responsible for clean-up inside the Rings and the show site, as well as all outdoor surrounding areas for their owned and handled dogs.

NO BAIT IS TO BE THROWN IN THE RINGS.

The Eastern Canada Dachshund Club Specialty judging will be held at 1:00 PM on Saturday.

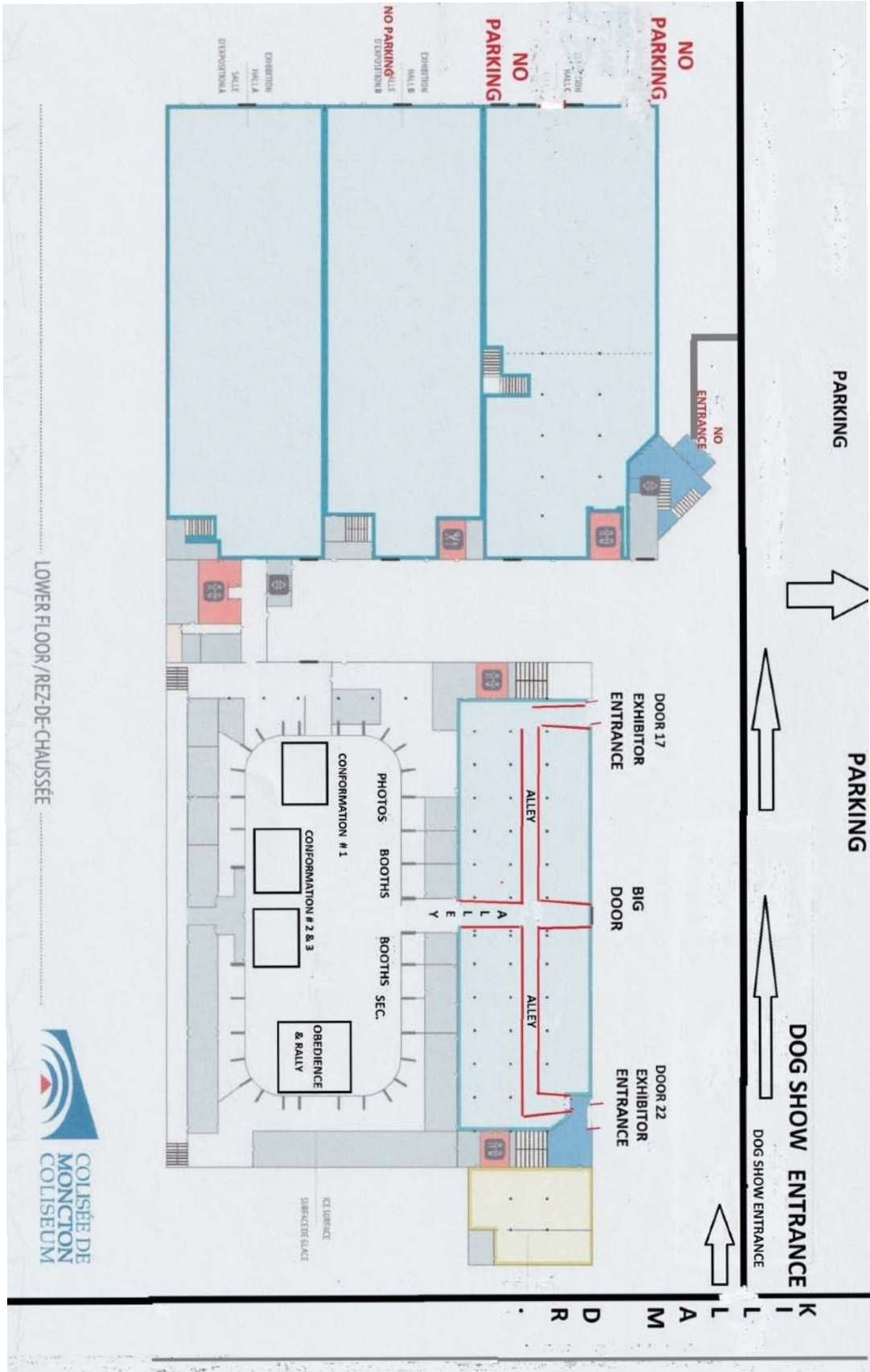
Junior Handling will be held at 12:30 PM on Sunday.
