JUDGING WILL START PROMPTLY AND WILL ADHERE AS CLOSELY AS POSSIBLE TO THE SCHEDULE PRINTED IN THIS PROGRAM. TIMES ARE BASED ON JUDGING AT THE APPROX. RATE OF 20-25 DOGS PER HOUR FOR CONFORMATION SHOWS.
