Judging Schedule

1. Judging will start promptly and adhere as closely as possible to this schedule
2. It is the responsibility of the Exhibitor to be at ringside when their class is called. It is not the responsibility of the Ring Steward to locate dogs. The Judge will not wait for any dog or handler delaying a class.
3. It is the duty and obligation of the show-giving club to see that a Judge, Club Official, Volunteer or any participant at an event held under these rules is not subject to indignities. The Club shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Section 19.7 Dog Show Rules)
4. The precinct of the Trials is the Paws for Fun building.
5. The Trial Superintendent is in complete charge of these Trials.

CLEAN-UP. All Exhibitors will be held responsible for clean-up on the show site and surrounding areas for their own dogs, or dogs they are handling. Anyone caught not cleaning up after their dog **WILL BE PROHIBITED FROM TRIALING** their dog or dogs at this event.

The building will open up at 09:00 and will close one hour after the end of the second Trial.

Non-Member Participation Fee

An annual “Non-Member” participation fee for Awards and Titles will be charged to a Canadian “non-member” of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the “non-member” will have a choice to (a) either become a CKC member, or (b) pay the “non-member” participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please note: These fees only apply to dogs wholly owned by “Non-CKC” members and are not applicable to CKC members.

Directions to Trial Site: From Halifax: Take Highway 102 North

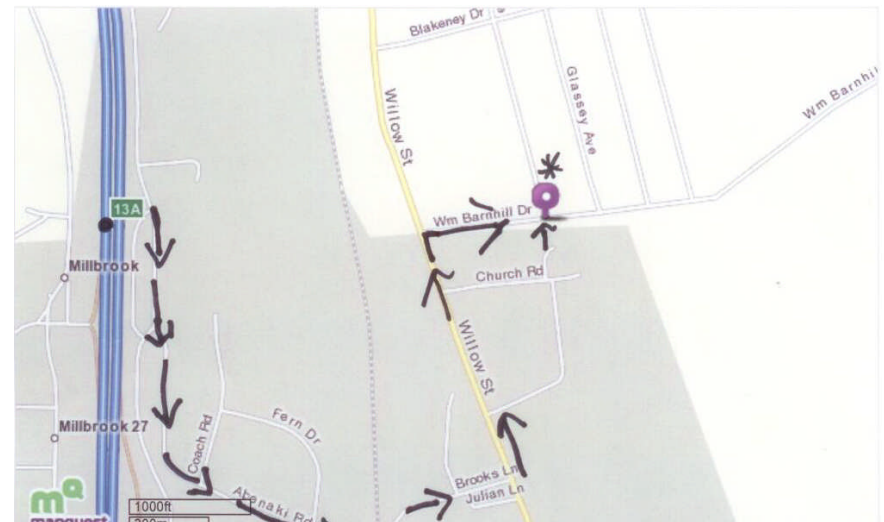
At **Exit 13A**, take ramp right toward Treaty Connector/Millbrook
Turn **RIGHT** onto **TOWER ROAD**, and then immediately turn **LEFT** onto **ABENAKI CONN**

Turn **RIGHT** onto **ABENAKI Rd.** **Note:** Road name changes to **BROOKS LN**

Turn **LEFT** onto **HWY 2/WILLOW ST**

Turn **RIGHT** onto **WM BARNHILL DR**

Turn **LEFT** onto **CROSSLEY AVE.** **Destination 214 CROSSLEY AVE.** The last intersection is WM BARNHILL. If you reach BLAKENEY DR, you’ve gone too far!
