Non Member Participation Fee (April 2011)

A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non member participation fee is paid in any year a title is earned and covers all titles and dog owned by that individual.

In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee.

Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer, or competitor at a rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline

Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
