CKC NON-MEMBER PARTICIPATION FEE

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line). The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques “Payable in Canadian Funds” or “At Par”. They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated. Thank You.”

GENERAL INFORMATION

The venue will be open from noon-on Tuesday, September 24, 2024.

Judging will not commence prior to 8:00 am

The precincts of the show will be 30' around the perimeter of the rings and gazebo.

Exhibitors are requested to keep their grooming and crating areas clean and tidy.

Dogs not entered in these shows will NOT be allowed within the precincts of the show.

The Show Superintendent will be in full charge of the show, governed by CKC rules.

If, because of riot, civil disturbance, or other acts beyond the controls of the management, it is impossible to open or complete the show or trial, no refund of Entry Fees will be made.

Noteworthy Farm Show Services and Fredericton Kennel Club will use care and diligence for the welfare of all dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of accident or misfortunes however caused.

Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.



GENERAL ENTRY INFORMATION

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept entries reaching the Show Secretary after the official closing date as published in this premium list.

No entry will be accepted unless all particulars called for on the entry form are shown thereon. **INCOMPLETE ENTRIES WILL BE RETURNED. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY ENTRY FEES.**

TELEPHONE ENTRIES CANNOT BE ACCEPTED.

It is your responsibility to verify the receipt of any electronic entries prior to the advertised closing date.

Noteworthy Farm Show Services reserves the right to refuse any entry, subject to CKC Dog Show Rules.

Identification cards and judging schedule will be mailed / emailed as soon as possible after entries close.

Conflicts between Dog Show Rules and the New Breed Standards The Board of Directors of the CKC, has ruled that where a conflict arises between the Breed Standards and the Dog Show Rules that the Dog Show Rules will take precedence.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. Changes or cancellation of any entry after closing date is prohibited.

In the event that the dog is absent, excused by a Veterinarian or Judge, disqualified, or barred from competition by action of the bench Committee, no entry fees will be refunded.

To avoid noise and confusion, there will be no individual dogs called to the ring by loudspeaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.

Only dogs eligible for registration with CKC may enter this show and trial.

Miramichi Kennel Club reserves the right to refuse any entries, subject to CKC rules.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Event Registration Number (ERN).

To obtain an ERN simply do the following:

1. send a photocopy of the dog's Registration Certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide the CKC with your full return address to enable the ERN to be sent to you.
4. Faxed requests will be accepted. Please indicate your VISA/MasterCard number and expiry date, the card holders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores.

TEMPORARY COMPETITION NUMBER

(* EFFECTIVE MARCH 2, 2020)

Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN.

A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN)

There is no fee to obtain a TCN, however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly.

* Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. *

If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog.

There will be a tab called TCN Dogs in the owner's Portal account.

A TCN is required to enter the BABY PUPPY CLASS, however, listing fees do not apply to baby puppies.

CONFORMATION CLASSES

Baby Puppy A dog 4 months up to 6 months on the day of the show.

Junior Puppy A dog 6 months up to 9 months on the day of the show.

Senior Puppy A dog 9 months and up to 12 months on the day of the show.

12-18 Months A dog 12 months and up to 18 months on the day of the show.

Canadian Bred A dog which was born in Canada.

Bred by Exhibitor A dog owned and handled by the breeder.

Open Class A dog 6 months of age or older

Specials Only Dogs who are Canadian Champions.

"EXHIBITORS ARE RESPONSIBLE FOR ENSURING THAT THEY ARE ENTERED IN THE CORRECT CLASS. PLEASE REFER TO THE CKC RULE BOOK"

The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing:	1	2	3-5	6-9	10-12	13 or more
POINTS ALLOCATED*	0	1	2	3	4	5

*Includes the dog awarded WINNERS

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder:

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

GRAND CHAMPIONSHIP POINTS

Grand Champion (GCh) The title of Grand Champion may only be earned after the completion of the CKC conformation championship. Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward. (a) Grand Champion Point System Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

(c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained. (a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship. (b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two

wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward. (c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained. (a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze. (b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained. (a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver. (b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Grand Champion Excellent (GChEx) The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website. To earn the title a dog must have earned the following during their career as a Special: (a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed) (b) three (3) Group 1st, or three (3) breed specialty best of breed wins. (c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles, (b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career. NOTE: 1. Exhibitors are required to complete the Grand Champion

Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above. 2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

Altered Champions & Championship Points 13.8.1 Championship points will be awarded as per Chapter 15, with the exception of 15.1.11. The winner of an Altered Best in Show shall be awarded points according to the total number of dogs in competition following the point schedule in Section 15.1.2.

CKC NON-MEMBER PARTICIPATION FEE

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line). The Non-Member Participation Fee is fee paid in the calendar

year (January – December) in which the dog achieved its title and/or titles.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques “Payable in Canadian Funds” or “At Par”. They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.”

***TCN FEE:** These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized-breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog as per CKC rules for this designation. Exhibitors must apply to the CKC for a “temporary competition number” (TCN) before the event closing date.

****Note:*** *Tests will run concurrently (i.e. each dog will run their second test in the same time block as their first). The running order will be cycled through TWICE, giving dogs a break between tests.**

PLEASE NOTE: EACH TEST IS 1 RUN.

For this event, Running order and times will once again be assigned by the show chair and emailed out to exhibitors at least 6 days prior to the events. However, should you have a conflict or a preference for a time, please contact the show secretary in writing after the closing date of September 11 but before September 19th and we will make every effort to accommodate your request for a certain time. You do not have to arrive at the venue until 15 minutes before start time for your assigned heat.

Note: Each test is its own event; therefore, dogs must be inspected each time. Inspection will take place 15 minutes

prior to the beginning of each time slot/heat.

All dogs in Sprinter Tests run the same distance (100 meters) but are assigned a handicap for points based on their height class. Please see the CKC Sprinter Rules & Regulations for further information.

CKC TCN Fee for each entry without a CKC number, per dog per test: \$11.50

Refunds only as per CKC Sprinter rule 2.4.4

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars.

This is an outdoor event. In the event of bad weather there is no cover provided over the rings.

Trials will not commence prior to 8:00 am

The show precincts will be a 150-foot (45m) perimeter from the exterior of the course.

The Trial Chair will be in full charge of the trials, governed by CKC rules.

If, because of riot, civil disturbance, or other acts beyond the controls of the management, it is impossible to open or complete the trial, no refund of Entry Fees will be made.

HOW THE EVENT IS RUN

Please read this carefully

You are responsible for reading the club waiver (attached) which you will **electronically sign** with your online entry. Your helper (if you bring one) must complete a paper waiver and bring it to the tests (or email it to

patrickmudge2@yahoo.ca beforehand). **You are**

responsible for calculating/checking your own points and knowing if your dog has achieved any titles. Your dog's Sprinter points (earned *after* August 28, 2019)

are now available on your CKC online portal. The calculations and handicaps are available via the Sprinter Rules & Regulations from the CKC website at:

<https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Sprinter-Rules-and-Regulations-Effective-January-1>

On arrival for your scheduled time slot:

1. When you arrive, go to the main check-in station for the lameness and in-season inspection. You will need to swab your bitch with a tissue for in-season check and all entries may also be measured to determine their handicap. **AS OF Jan 1, 2024, bitches in season are permitted to enter these test but must weat clean, dry, snugly fitting panties specifically designed for the purpose of preventing/containing discharge. Bitches in season will run in the last heat at the end of the day.**
2. **Two to three dogs before your run**, proceed to the start line waiting area with your dog and have your Catcher (which may be you or your helper) proceed directly to the finish line **with a leash. *Catchers CANNOT wait at the start line then walk/run down the chute when their dog steps to the start line for their turn. The Catcher must ALREADY be at the finish line and ready to catch the dog as the dog steps to the start line with their Releaser.*** Dogs may run "naked" or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line (**NO running in martingale or slip collars and NO tags on catch**

- collars**). You may walk your dog to the start line in a martingale, slip collar or harness, but it **MUST** be removed prior to releasing them.
3. Once your dog runs and is caught and leashed, **clear the chute area**, and prepare for their second run. For safety reasons, **please stay CLEAR of the chute when walking your dog back from the finish line.**
 4. The running order is cycled through **TWICE** (repeat steps 1-3) and the dog runs its second, and final, run for the day.
 5. Once you have completed your two runs per dog, collected your ribbons and times from the table, and taken your photos, please feel free to stay and enjoy the day at Noteworthy Farm, have lunch at the Woodsmoke Café and cheer on your friends. There are other events you might want to participate in.

OTHER EVENT INFORMATION

You will need to crate your dog in/by your car. There will be no shade provided so please keep your dog cool by keeping windows open, using shade cloths, and providing fresh water (Water is available on site). There's plenty of room for pop-up tents.

All competitors must bring ***TWO* leashes**, one each for the Releaser and Catcher. **A slip leash is ideal for the Catcher.** You may bring your own helper to act as your Catcher or Releaser. If you are not bringing a helper, you may list another exhibitor as your helper or request that a club volunteer release your dog. **This information will be gathered in a form via email ~2 weeks before the tests.** Also, Noteworthy Farm would appreciate and will post any event pics/candids anyone wishes to share. (again to patrickmudge2@yahoo.ca)

Please ask for help when getting your title and Q ribbons from the check-in table. There are different rosettes for each Sprinter title and club members will help you get the right one.

There will be a "photo booth" set up near the parking area with title/event boards. Feel free to take some pictures of

your dog with their ribbons.

****Miramichi Kennel Club and Noteworthy Farm will be following all current federal, provincial, and local COVID rules at the time of the tests **** Further information, if required, will be emailed to participants with the running orders prior to the event

Important Notes: Please respect instructions, pick up after and maintain control of your dog. **Retractable leads, prong collars, and electronic collars are not allowed on the premises. Owners may have their dog wear a muzzle, if they desire. Dogs may run “naked” or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line. You may walk your dog to the start line in a martingale, slip collar or harness, but it MUST be removed prior to releasing them.** There is a risk of injury for all active sports; you can reduce this risk by warming up and cooling down your dog, only running your dog when you feel the field and weather are appropriate and staying aware of your environment and any safety hazards. A \$10 fine, payable to Miramichi Kennel Club will be levied for any dog loose on the field from the time of inspection until the completion of all events for the day. A \$10 fine, payable to Noteworthy Farm will be levied for any exhibitor not picking up after their dog. Events run rain or shine.

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Sprinter Rules & Regulations are available from the Canadian Kennel Club online or via mail. Tel: 1-800-250-8040.

CKC Regulation: It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Test Chairperson shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

ERRORS IN RECORDED RESULTS: The CKC will not consider a request for any corrections to results if

received more than 90 days following the date(s) of the event(s).

Eligibility: Purebred or mixed-breed dogs must be at least 12 months of age that are: (a) Individually registered with the CKC, (b) Have an Event Registration Number (ERN), (c) Have a Performance Event Number (PEN), (d) Eligible for registration with the CKC, or (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed (f) Have a Canine Companion number (CCN) if it is a mixed-breed.

- Splashes include up to **three minutes** on the dock for **one optional practice jump** and **two judged jumps**. You must inform the judge

prior to your jump if you want it to be considered a "practice jump".

- This event is an **Open Splash** event. This is done at Portable Dock trials and other shows that have timing conflicts with other dog events. The time for each splash for the day will be set such as 9am for example for all the splashes. You have **between the posted start time and end time** (either before AR starts or the end of the last day, usually 3pm) to complete your splashes for the day. When you check in you will be handed "Splash Cards" for each splash that you pay for. When you are ready to jump during the day, hand a splash card to the wrangler to get put into the running order. It is the handler's responsibility to be sure to be present it before their turn to jump. Please be aware that at many events, the running order board fills very quickly and early in the day.
- **Please Note:** You must pay for all pre registered splashes at time of check-in. Any splashes not paid for will be put back into the event's on-site registration availability list and result in a no-show. If you are registering multiple dogs there will be a no-show for each dog. You are responsible for all pre-registered splashes.

- Each distance jumping Splash allows **2 judged jumps**, back to back. The longest jump of them will be your Qualifying Score.
- You can earn a [Diving Dog Title](#) at this event. You must have five Qualifying Scores within a Division. NADD titles are recognized by the AKC and CKC through their recognition programs.
