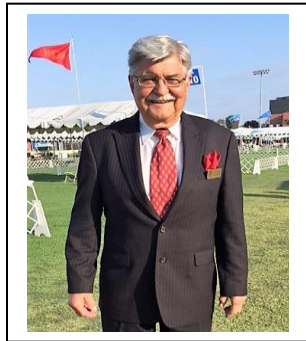

JUDGES PROFILE

Richard Lopaschuk, BC, Canada



A retired Government of Canada employee and is now working at his own business as a Water Management Consultant. Started in purebred dogs in 1966 with German Shepherd Dogs in the obedience ring and graduated to conformation a year later. Over the next 53 years bred many champion German Shepherd Dogs, Miniature Schnauzers, Cairn Terriers and Papillons. Also, bred and exhibited Wire Fox Terriers and Pointers. Richard, along with his wife Nancy still breed and exhibit Papillons.

Richard is a Life Member of the Canadian Kennel Club and was on the Board of Directors of the CKC for 14 years, retiring from the Board in 2002, and re-appointed to the Board for 2016-17. Started judging in 1989 with the Terrier Group and is now an All Breed Judge in Canada.

He has also judged internationally in addition to Canada, Australia, BIS 2005 Melbourne Royal, Argentina, Brazil, Chile, China, Columbia, India, Indonesia, Japan, Mexico, New Zealand, Philippines, South Africa, Sweden, Thailand and the United States.

Richard Paquette, Ontario, Canada



Richard has been involved in purebred dogs since 1971. He began his career in dogs with primarily Shih Tzu with kennel name Wenrick, but along the way has owned and bred Samoyeds, Afghans, Salukis, Whippets, Brussels Griffon, Maltese, Pekingese, Lakeland Terriers and Wire Fox Terriers. Shih Tzu and Lakelands are his main breeds and he has produced over 300 Canadian Champions, 80 American Champions, 20 different Best In Show winners and 12 National Specialty winning dogs.

Richard is now a retired professional dog handler, a profession he enjoyed for 15 years. During this time he finished over 500 champions in 80 different breeds and won over 150 All Breed Best in Shows on 16 different breeds. He also owned and piloted a Lakeland Terrier, "Danny", Am Can Bda Ch Jamelyn's Second Edition to #1 All Breeds in Canada in 1989. His Shih Tzu 'Panda' Am

Can Ch Wenrick's Don't Stop Believing won the Toy Group First at the prestigious Westminster Kennel Club shows at Madison Square Gardens in New York in 2016.

He has served on the executives of All Breed and Specialty breed clubs and is currently a Director of the Canadian Kennel Club and President of the Canadian Shih Tzu Club. Richard has been honored with Life Memberships in the Canadian Kennel Club, the Sudbury & District Kennel Club and the Canadian Shih Tzu Club as well as being awarded an Honorary Membership in the Canadian Professional Handlers Association.

Richard is a CKC Licensed All Breed judge, a founding member of the Canadian Dog Judges Association (CDJA) and a member of the American Dog Judges Association (ADSJA). In addition to Canada and the USA, he has judged in Argentina, Australia, New Zealand, Bermuda, Brazil, Colombia, Chile, Peru, Uruguay, China, Japan, Korea, Mexico, Nicaragua, Philippines, Taiwan, South Africa, Israel, Spain, Denmark, Italy, Finland, Latvia, Russia, Sweden and Ireland.

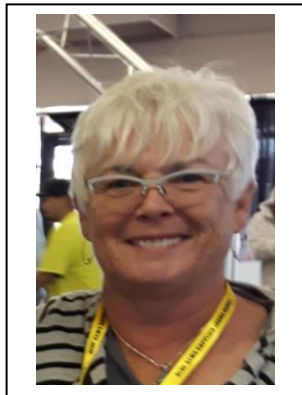

Yearling Male/Female – 12 months and under 18 months

For final judging, the first place Juvenile in each of the classes will be brought together for Best in Sweepstakes. A rosette will be awarded to Best In Sweepstakes.

First in each class 25% of entry fee for the class

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **MOUNTAIN DAYLIGHT TIME.**
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided here under.

The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

*Dogs Competing	1	2	3 to 5	6 to 9	10 to 12	13 & More
Points Allocated	0	1	2	3	4	5

*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

If a dog awarded Winners is also awarded Best of Breed at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total. If a dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing in Specials Only shall be included in the total. If a dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total. If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total. The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification: Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Dog shall be deemed to have indirectly defeated the Specials bitches, and is thus entitled to add them to the number of dogs and bitches defeated. In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points provided that a dog was defeated at the group level.

A dog may not be credited with more than five (5) championship points in a single show. Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group. A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level. In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must:

(Earn at least 10 championship points under at least three (3) different judges; Be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); Have earned at least one 2-point win either at the breed or group level. The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean:

- (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level;
- (b) each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing;
- (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Breed or group placing.

Grand Champion (GCh) Point Schedule

The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship. To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward. (a) Grand Champion Point System Points towards the Grand Champion title, at breed level, are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch).

(b) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

The title of Grand Champion shall not be awarded retroactively and all points towards this title must be achieved after the date of January 1, 2013.

CLASSIFICATION-CONFORMATION

REGULAR CLASSES

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

12-18 MONTH CLASS - for dogs 12 months of age and under 18 months of age on the day of the show

CANADIAN BRED - for dogs born in Canada, Champions in any country excluded.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder.

OPEN CLASS - shall be for all Dogs.

SPECIALS ONLY – Dogs which have a recorded CKC registration, Event Registration Number (ERN) or Miscellaneous Certification Number (MCN) and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship

The following classes will be provided, divided by sex. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

NON-REGULAR CLASSES

VETERAN CLASS - In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran Best Veteran in Breed Best Veteran in Group Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

BABY PUPPY CLASS – Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes.

CLASSIFICATION - RALLY OBEDIENCE (Approximate Ring Size 40' x 50')

The following regular CKC Rally classes (not divided by sex) will be provided for purebred dogs of any breed and those breeds as designated on the list of miscellaneous class breeds and of either sex. No dog may be entered in both the Novice A and Novice B or Advanced A and Advanced B or Excellent A and Excellent B at any one trial.

RALLY NOVICE A: 9.1.1 Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. Please see 9.1.2 in the Rally Obedience Rule Book which states in part ...

RALLY NOVICE B: 9.2.1 Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. 9.3 All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY INTERMEDIATE: 10.1.1 The Rally Intermediate Class is an elective class and earning a title is not a requirement to enter Rally Advanced. 10.1.2 This class shall be for dogs that have earned a RN Title.

RALLY ADVANCED A: 11.1.1 This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. Please see 10.1.2 in the Rally Obedience Rule Book which states in part ...

RALLY ADVANCED B: 11.2.1 This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. 10.3 All exercises are judged off leash. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT A: 12.1.1 This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. Please see 11.1.2 in the Rally Obedience Rule Book which states in part.

RALLY EXCELLENT B: 12.2.1 This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Sit Stay Exercise: See 12.3.1 – 13.3.6 A sit stay exercise must be included in the Rally Excellent classes

RALLY MASTER: 13.1 This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
