SET UP

GENERAL INFORMATION

- On the day of the show/trial, the show/trial superintendent will be in complete charge of the show/trial.
- Only dogs properly entered in the show/trial will be admitted.
- The building will be opened 1 (one) hour before the start of the show/trial. Dogs may be removed from the building when not required for further judging.
- Dogs <u>must not</u> be left in the building overnight.
- Dogs and their handlers should arrive in adequate time for their breed judging (allowing for absentees) and will be excused for each show when not required for further judging. It is the responsibility of the exhibitors/handlers to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs/handlers is not possible and handlers showing several breeds must arrange alternate handlers if judging time for their breeds conflict. Judging will proceed without any dog not present when called by the ring steward.
- The show/trial committee will use due care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show/trial, no refund of entry fees will be made.
- It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Show/Trial Committee shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- The show/trial grounds are defined as the confines of The Jack Byrne Arena (Torbay Road, NL.)The authorities of the shows/trials may remove any dog from the show/trial building on account of viciousness or disease.
