

TEST DETAILS:

- Standard CKC Rosettes awarded to all qualifying dogs
- Pigeons and/or game birds will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX. Hunt test handlers shall be attired in dark or customary hunting attire.
- Refunds will be given for Bitches in Season. A Veterinarian certificate must be submitted prior to test
- WCX followed by WCI in each series on Sunday, June 26
- Running order is by random draw within each test level
- Recommended arrival time is $\frac{1}{2}$ hour prior to the start time for each stake.
- Lunches will be available at the headquarters

The Labrador Owners Club is a member in good standing with the Canadian National Master Retriever Club. As of July 1, 2010 only passes at Hunt Tests hosted by clubs in good standing of the Canadian National Master Retriever Club are considered in determining eligibility to enter the National Master Hunt Test Stake.

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011.

An annual non-member participation fee for awards and titles will be charged to a <u>Canadian</u> non-member of the CKC. The fee will match the ERN fee.

Excerpt from CKC Rules & Regulation for Working Certificate Tests (section 14.7)

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Excerpt from the CKC Rules & Regulations for Hunt Tests (section 20.7)

It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at a hunt test held under these regulation, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
