## **RULES GOVERNING THESE SHOWS**

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM THE ENTRY WAS MADE.
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING.

### **ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES**

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder. SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points (effective January 1, 2012) (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN) (3) on win must be a minimum of 2 Ch points.

## **DAVOR JAVOR**

I have been interested in dogs since I was a kid, I just love dogs. My first dog was an American Cocker bitch, Champion and my first BIS winner.

We have had Champion Afghan Hounds, English Cockers and Golden Retriever as well. Today we have Old English Sheepdogs only. Our first OES came in 1985, he became Champion in many countries and multiple BIS winner. Later on we imported dogs from UK and started with serious breeding under the kennel name Reata. The OES that we owned or bred have won their championships in Argentina, Brasil, Chile, Uruguay, USA, Canada, Australia, China, England, Sweden, Denmark, Finland, Germany, Greece, Portugal, Spain, Gibraltar, Luxembourg, Austria, Hungary, Italy, San Marino, Serbia, Russia, Slovenia, Yugoslavia, Moldova, Montenegro, Romania, Georgia, Cyprus, Macedonia Bulgaria, Lithuania, Latvia and Croatia,

We have BIS winners in Europe, South and North America, Group Winners both at the World and European Shows, WD and two times AOM at the American National, two times BIS at the Euro-OES Show, BOB at Crufts etc. Currently we have 3 OES living with us: Pipi who is 3 x European Champion and #1 All Breeds in Croatia 2012, Kiara who is World Champion 2013 and our big baby Gigi. We achieved all that never having more than five adults at home.

I've been judging dogs for more than 25 years, and I am approved by the Croatian KC and FCI to judge about 120 breeds. I have judged so far in Austria, Australia, Croatia, Czech Republic, Denmark, England, Finland, France, Germany, Holland, Hungary, Italy, Norway, Portugal, Russia, Serbia, Slovakia, Slovenia, Spain, Sweden, USA and Yugoslavia. Very proud that I was the first Croatian judge who gave CC's in England.

In August 2014 we moved to Canada and now I am living in Mississauga, ON.

**EXTRACTS FROM CKC CONFORMATION SHOW RULES**

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

8 - ENTRIES and ENTRY FEES

**Section 3.1**

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) it is not a Miscellaneous breed
- (b) if born in Canada, is eligible for individual registration
- (c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. A listing fee of \$8.82 must accompany the entry of a "listed" dog at a show held under these rules.

**Section 2.3:**

INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

**Section 8.2:**

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 14 - DISQUALIFICATION

**Section 1.4**

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules  
CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

## **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered

**JUNIOR PUPPY CLASS** - This class shall be for any dog **6 months of age and under 9 months of age** on the day of the show

**SENIOR PUPPY CLASS** - This class shall be for any dog **9 months of age and under 12 months of age** on the day of the show

**12 to 18 MONTH CLASS** – This class shall be for any dog **12 months of age and under 18 months of age** on the day of the show

**CANADIAN BRED CLASS** - This class shall be for any dog born in Canada.

**(Champions of any country excluded)**

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring owner/breeder. The handler **MUST** be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

**OPEN CLASS** - This class shall be for all dogs

**SPECIALS ONLY CLASS** - This class shall be for any dog which has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. **Note: A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded**

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

## **NON-REGULAR CLASSES**

**BABY PUPPY CLASS** - This class shall be for any dog **3 months of age and under 6 months of age** on the day of the show. (note: winners of these classes **DO NOT COMPETE FOR POINTS**). **The class will be judged after Best Puppy in Breed, after Best Puppy in Group, PRIOR to Best in Show**

**VETERANS CLASS** – Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show **(This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and PRIOR to Best in Show)**

**SEXUALLY ALTERED CLASS** - Eligibility for the Altered classes shall be limited to dogs over six months of age, which have been sexually altered by veterinary procedure. Points MAY NOT be carried from the regular competition judging to the Altered class judging. This class WILL be judged upon the completion of Veteran in Breed, Veteran in Group and Veteran in Show judging.

## **REGULAR OBEDIENCE CLASSES**

NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & NOVICE "B" AT SAME TRIAL

NO DOG MAY BE ENTERED IN BOTH OPEN "A" & OPEN "B" AT SAME TRIAL

**NOVICE "A"** - The Novice A Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families, and must be eligible to handle under section 10.1.4. No person who has trained or exhibited a dog that has earned a C.D.X. title shall be allowed to handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**NOVICE "B"** - The Novice B Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercises.

**OPEN "A"** - The Open A Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner or a member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**OPEN "B"** - The Open B Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher obedience titles may enter in the Open B Class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the group exercises. No dog may be entered in both the Open A and Open B classes at any one trial. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

**UTILITY CLASS "A"** - for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class. The handler of any dog in this class must be the owner or a member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**UTILITY CLASS "B"** - The Utility B Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

## **TRANSITION OBEDIENCE CLASSES**

**Pre-Novice** - shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

**Novice C** - shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercises. Dogs may compete in the Novice C class indefinitely. Scores earned by dogs entered in the Novice C Class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered the Novice C Class in addition to any other official or unofficial classes for which they are eligible.

**NOVICE INTERMEDIATE CLASS** – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice "C" and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

**PLEASE NOTE: The word "trainer" means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family.**

No dog may be entered in both Rally Novice A and Rally Novice B at any one trial.

**Rally Novice B Class:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**Rally Intermediate Class:** The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes. This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**Rally Advanced A Class:** This class shall be for dogs that have earned the R. N. title but have not earned the R. A. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**Rally Advanced B Class:** This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class

**Rally Excellent A Class:** This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

**Rally Excellent B Class:** This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

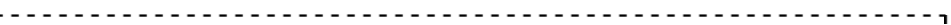
