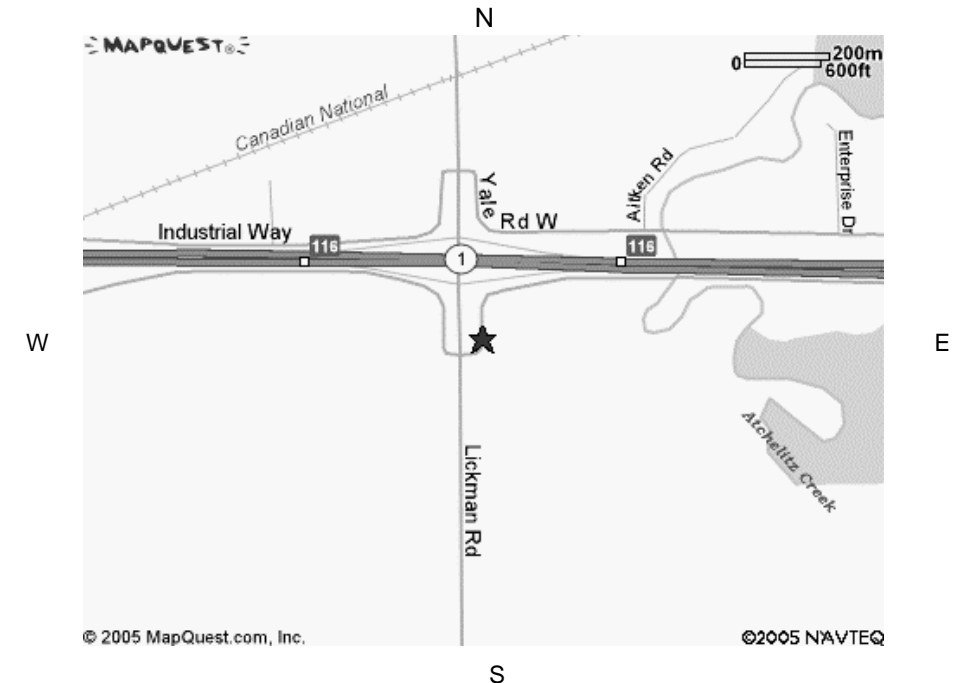

ADDITIONAL CLUB RULES

1. Crates will be allowed at ringside during the judging of your specific breed **ONLY** and **MUST BE** removed immediately after, **NO EXCEPTIONS**.
2. There will be an area designated for the exercising of dogs. No dogs will be allowed to exercise elsewhere on the grounds. The Auld Lang Syne Dog Association asks that you pick up after your dogs. Offenders may lose show privileges.
3. Using the building facilities is a privilege, please be considerate. Dogs are not allowed in the washrooms.
4. The Welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.
5. The Club is not responsible for lost or stolen property from exhibitors or vendors/concessions.
6. The Club reserves the right to refuse an individual's entries, for just cause
7. Delays waiting for dogs are not possible and handlers with several breeds MUST arrange for alternate handlers if judging times for their dogs' conflict.
8. The Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors. (See 'AGREEMENT' on the back of the entry form)
9. The Club reserves the right of restricting exhibitors grooming space
10. Heritage Park is a NON SMOKING facility, there are no exceptions. If you wish to smoke, please do it outdoors. Fire Lanes must be kept open everywhere. Please be considerate and think defensively.
11. PLASTIC sheeting MUST be under ALL EXPENS
12. **Any tape used in the building has to be easily removable and must be removed after the show is completed. COLORED TAPE IS NOT ALLOWED.** You must leave your setup in the same clean condition you found it in when you first arrived at the show.
13. EXTENSION CORDS, if laid across an aisle MUST be taped down properly – think of the safety of others!
14. Aisles must be kept open at all times to allow everyone easy and speedy exit in case of emergency.

I am a retired Health Care Administrator. I have been showing and training dogs since 1965, when I obtained my first Irish Setter. Since then my husband and I have shared our home with Irish Setters for 45 years. This breed quickly stole my heart as my first Irish 'Titan' taught me about his lively personality and humbled me in many ways. Even as we learned together we gained Best In Show wins and Obedience Titles.

Throughout the years under the prefix KIAN, we raised Irish Setters and Cairn Terriers and exhibited them to Group, Specialty and Best in Show wins. Several of our Cairn Terriers have been awarded Top Show Dog awards.

Using humour, exasperation and patience the Setters and I also gained many Obedience titles.

Our family has also owned, shown and trained a number of different breeds including, Cairn Terriers, Boxers, and Doberman Pinschers. In between we rescued a Great Dane, Afghan Hound and a Tibetan Mastiff.

MRS WENDY MAISEY

Wendy Maisey is the CKC Director for AB/NWT/NU, she resides in Calgary, Alberta, Canada with her husband, several Cavaliers and one Berger Picard. Originally in Dobermans, she got her first Doberman in 1972 and over the next 35 years produced many champions, BIS & BISS winners that set records for the breed, as well as some outstanding performance dogs. She also bred Miniature Pinschers in the 80's that are behind some of the most successful kennels today.



For the last 14 plus years she has bred Cavalier King Charles Spaniels with a strong focus on the whole colours that have also set records within this breed including the first whole colour to win the Canadian National Specialty. Now retired from a demanding career in Project Management, she is very active in Agility with her Cavaliers being ranked at the top in their breed in several organizations including the first Cavalier to get an Agility Master Championship. She is also the Chair of the CKC Agility Council.

Wendy began judging conformation in 1999 and is approved for 6 groups (Sporting, Working, Toys, Herding, Non Sporting, Terriers) and provisional for Hounds. She has judged across North America and has declined all requests from other countries.



IMPORTANT NOTICES TO ALL EXHIBITORS and VENDORS FROM THE MANAGEMENT OF HERITAGE PARK

- 1) Due to the ongoing problem in the grooming area with exhibitors continuing to pour buckets of wash water into the garbage barrels, mixed with dog fecal matter and urine, makes it very unpleasant for the custodial staff as the bags are leaking and breaking open when being changed. Our resolution to this problem will be to remove the garbage barrels and place a 4 yard dumpster on the south end of the grooming area for the participants to use.
- 2) To the vendors – cardboard is not to be left on the floor at anytime. There is a large cardboard recycling bin located on the south end of the building between floor 1 and 2. Please ensure you that you place all cardboard in the recycling bin.
- 3) Parking is still a continuing problem – There is NO PARKING permitted within 6 meters of the buildings, in front of the fuel tank (east side of building), the North and South side of the storage building behind the main building, in front of the fire hydrants, in Handicapped parking (if an approved sign is not displayed) and on the south of floor 1 which is Concession Staff parking only. Effective October 30, 2006 Heritage Park will be working with a local towing company to patrol the lot and will have vehicles removed that are in violation of the no parking areas. Additional signage has been put in place with the name and contact number of the towing company.

Mr. Pinsker and his wife Monika started to breed and show Boxers under the “Mephisto” prefix in 1969. They produced the No. 1 Boxer in Canada as well as No. 1 All Breed dog in Japan. Mr. Pinsker and his wife also have owned/bred/exhibited Smooth Fox Terriers, Shiba Inus, Whippets and Akitas. Mr. Pinsker started to judge in 1978 and has been licensed to judge all breeds since 1990. CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered

JUNIOR PUPPY CLASS - This class shall be for any dog **6 months of age and under 9 months of age** on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog **9 months of age and under 12 months of age** on the day of the show

12 TO 18 MONTH CLASS - This class shall be for any dog 12 months of age and under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring owner/breeder. The handler **MUST** be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog which has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. **Note: A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

NON-REGULAR CLASSES

(if offered by the club, refer to individual Premium List)

NOTE: Any dog entered in a Non-Regular class **MUST** also be entered in a regular class or for Exhibition Only on the same day, dogs being entered in a Parade may be spayed, neutered or in an unorthodox trim **PROVIDED** they are entered in Exhibition Only

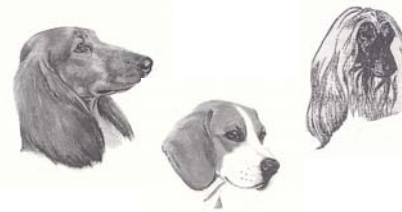

EXTRACTS FROM THE CONFORMATION SHOW RULES & REGULATIONS

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

CHAPTER 8 - ENTRIES and ENTRY FEES

Section 8.3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

(a) it is not a Miscellaneous breed

(b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered.

A listing fee of \$8.82 must accompany the entry of a "listed" dog at a show held under these rules.

Section 8.2:

INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being cancelled.

Section 8.6.2:

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees. Clubs may refuse to accept entries from any exhibitor who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order, cash or certified cheque.

CHAPTER 14 - DISQUALIFICATION

Section 14.1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 14, Section 3 of the Conformation Show Rules and Regulations

CHAPTER 5 – SHOW OFFICIALS

Section 5.1.5

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.
