Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. Class divided by sex only not by age. Altered dogs attaining Winners Male and Winners Female may earn Championship points.
