I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefore sustain by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this round, howsoever such injuries, death or damage to property may be caused, and whether or not the same may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
