- EXHIBITORS AND OWNERS CERTIFY THAT THE ENTERED DOG IS NOT A HAZARD TO PERSONS, DOGS OR PROPERTY.
- EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING, BUT NOT LIMITED TO, THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTING, SECURITY MEASURES OR LACK THEREOF, ELECTRICAL APPLIANCES, SHOW RINGS, PARKING AREAS AND THE PRESENCE OF UNFAMILIAR ANIMALS AND PEOPLE; EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.
