- To comply with instructions issued by the Canadian Kennel Club we will be unable to accept, cancel, or substitute an entry reaching our Show Secretary after the closing date.
- All entry confirmations and Judging Schedules will be mailed or emailed as soon as possible after entries close.
- It is **YOUR RESPONSIBILITY TO VERIFY** the receipt of any electronic entries prior to the advertised closing date. A valid means of payment must accompany all entries.
- **Refunds will not be given for anyone double entering the same dog.**
- All exhibitors should review Section 4 – Judges – General, also section 1.3 of the CKC Conformation Rules & Regulations, "It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subjected to indignities...".
- Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made.
- It is the **exhibitor's responsibility** to have the dog in the ring when the dog's class is called to be judged.
- The South Western Ontario Sporting Dog Club, its officers & associates will use due care & diligence for the welfare of dogs, spectators, and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or misfortune, to either dogs, exhibitors, spectators, or patrons. If because of riots, civil disturbances, or other acts beyond the control of the management, and it is impossible to open or complete the show, no refund of entry fees will be made.
- **The Show Superintendent** will be in complete charge of the show and/or trial, which will be governed by the rules of the Canadian Kennel Club (CKC).
- **SHOW PRECINCTS** 20 feet from each ring

ERN (Event Registration Number)

Effective as of January 01, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC Registration Number, BUT, will require an ERN (Event Registration Number). The ERN **MUST** be applied for within 30 days of the first day of entering a CKC event. For further information Contact: The Canadian Kennel Club, Voice (416) 675-5511 or fax (416) 798-9671, - 9:00am to 5:00pm Dogs may be entered as listed until an ERN or registration number is issued.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian Dollars. Due to the constantly fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank You.

Champions and Championship Points

Chapter 15.1 A dog awarded WINNERS at a championship show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded WINNERS shall be as provided hereunder.

15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded

Winners shall be:

| Dogs competing | 1 | 2 | 3 to 5 | 6 to 9 | 10 to 12 | 13 or more |
|-----------------------------------|----------|----------|---------------|---------------|-----------------|-------------------|
| Points Allocated | | | | | | |
| *includes the dog awarded WINNERS | 0 | 1 | 2 | 3 | 4 | 5 |

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

Note: To determine the number of championship points earned by a dog awarded WINNERS, total all the dogs in competition which the dog defeated, directly or indirectly, for, the highest of the following official breed awards, Winners, Best of Winners, Best of Breed, or Best of Opposite Sex, then consult the schedule set forth above.

Section 15.1.8, ... a dog awarded WINNERS which also places in the regular group competition shall be credited with the following additional points, provided that a dog was defeated at the Group level.

Section 15.1.9, A dog may not be credited with more than five (5) championship points in a single show.

Section 15.1.11, A dog awarded WINNERS which also places Best in Show at an all-breed Championship Show shall

be credited with five (5) championship points inclusive of any points earned at breed or group level.

Section 15.1.12 (c), In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must...have earned at least one 2 point win either at the breed or group level.

Moving a Class Dog to Specials

Chapter 8, Section 8.9.1, A dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a championship in accordance with these rules but at the time of the closing of entries

for a show has not received confirmation of the title, may be transferred from one of the regular classes to "Specials Only", providing the transfer is submitted to the Show Secretary in WRITING by the owner or handler at least one (1) hour prior to the opening of the show.

Section 8.9.3, When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to specials must be made prior to the scheduled opening of the first show.

Every day of a two or more day show is a separate show. Please note that this rule is effective up to one (1) hour prior to the opening of the show. NOT one hour prior to the judging of the breed.

Important Note regarding Emails & Faxes

It will be the responsibility of the exhibitor to ensure that any electronic submission, either, email, Facsimile, or any document transmitted electronically, reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations. Sent fax receipts, and or, copies of sent emails, will not be taken as evidence of receipt by recipients.

Trailer Parking / Camping Information

Overnight Parking will be allowed in the parking lot, however, **NO** electrical or water hook-ups are available in the parking lot.

RULES

Entry must be made on a special entry form as provided by the C.K.C. and available from the Show Secretary.
A Junior Handler may compete with any dog entered in the Conformation Show provided he/she has the consent of the owner or agent to do so. If necessary, due to conflict, substitution of dog will be allowed.
Dogs being used in the competition, **MUST BE OF APPROPRIATE SIZE AND TEMPERMENT FOR THE JUNIOR HANDLER.**

CLASSES OFFERED AT THIS SHOW

PEE WEE

1A. JUNIOR NOVICE

For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.

1B. JUNIOR OPEN

For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have won six first places with competition in the Junior Novice Class, OR any handler wishing to enter this level. It is understood that once that handler has entered and competed in the Open Class, he/she may not compete in the Novice Class again.

2A. INTERMEDIATE NOVICE CLASS

For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.

2B. INTERMEDIATE OPEN CLASS

For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have won six first places in the same class with competition.

3A. SENIOR NOVICE CLASS

For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have not won six first places in the same class with competition. Handlers from the Intermediate levels progress to this class.

3B. SENIOR OPEN CLASS

For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have won six first places with competition in the Senior Novice Class and for any handler who has progressed through the Intermediate Open level and feels that he/she has enough experience to compete at this level.

4. BEST OVERALL

SWEEPSTAKES & VETERAN SWEEPSTAKES: Saturday, July 20, 2013

Judge: Jo Anne Griffith, Jordan Station, ON

- Dogs must be entered in one of the regular CKC classes
- Entries will be divided by sex: **Sweepstakes** 3-6 mos, 6-9 mos, 9-12 mos & 12-18 mos
Veteran Sweepstakes 7-9 years, 9-11 years & 11 years and over
- The class winners will be judged together for Best in Sweepstakes and Reserve Best in Sweepstakes
- Sweepstakes will start at approximately **12:00 noon**, followed by Veteran Sweeps
- Veterans may be spayed or neutered and can be entered in Exhibition Only or any of the regular classes

Prize Money will be divided as follows: **25%** retained for ribbons and administrative costs, **15%** for Best in Sweepstakes, **10%** for Reserve Best in Sweepstakes. The remaining monies divided among the class winners in the following way: First – **20%**, Second **15%**, Third **10%**, Fourth **5%**.
Rosettes will be awarded for first in each class and for Best in Sweepstakes and Reserve Best in Sweepstakes.

Non Member Participation Fee
(April 2011)

- A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

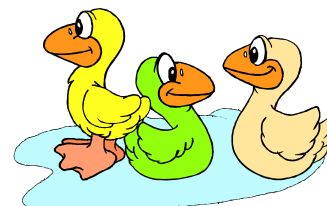
THE FIRST ANNUAL “Chuck-a-Duck”

A duck toss will take place at approximately 12:00 o'clock noon on Sunday.

Exhibitors who have entered the same dog for **both** the Saturday and Sunday shows will be able to obtain a rubber duck from the Show Secretary.

At approximately 12:00 noon ducks will be tossed from outside the ring towards a designated target inside the ring. Ducks will be numbered and the owners of the three ducks which land closest to the target will be awarded a prize.

Closest duck to target = \$200.00
Second closest duck to target = \$100.00
Third closest duck to target = \$ 50.00



Winners may obtain their prize money from the Show Secretary.

OFFICIAL CLASSES

Pre-Novice – for any dog which has not earned the title PCD or CD

Novice A – for any dog which has not earned the title CD, and whose handler has not trained or exhibited a dog that has earned a CDX. Dog must be handled by owner or a member of the immediate family.

Novice B – for any dog that has not earned the title CD.

Novice C – for any dog which has earned any obedience title prior to the trial closing date

Novice Intermediate – for any dog which has earned any obedience title.

Open A – for any dog which has earned the title CD, but has not earned the title CDX, and whose handler has not trained or exhibited a dog that has earned a UD. Dog must be handled by owner or a member of the immediate family.

Open B – for any dog which has earned the title CD.

Utility A – for any dog which has earned the title CDX, but has not earned the title UD, and whose handler has not trained or exhibited a dog that has earned a MOTCH. Dog must be handled by owner or a member of the immediate family.

Utility B – for any dog which has earned the title CDX or UD.
