## LUNCH

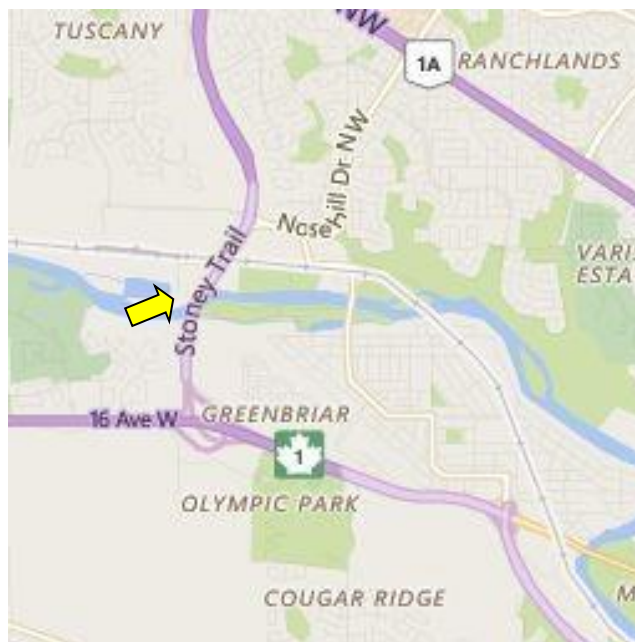
