If your dog is entered only in ASCA classes and not entered in the CKC show in Camrose, you must enter in Exhibition Only on a Battle River Canine Association (BRCA) entry form to have your dog in the building prior to the conclusion of the judging for CKC Best in Show. Puppies are not allowed in the building until after CKC Best in Show. - EXHIBITORS AND OWNERS CERTIFY THAT THE ENTERED DOG IS NOT A HAZARD TO PERSONS, DOGS, OR PROPERTY.
- EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING, BUT NOT LIMITED TO, THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTING, SECURITY MEASURES (OR LACK THEREOF), ELECTRICAL APPLIANCES, SHOW RINGS, PARKING AREAS AND THE PRESENCE OF UNFAMILIAR ANIMALS AND PEOPLE. EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.
