LUNCH

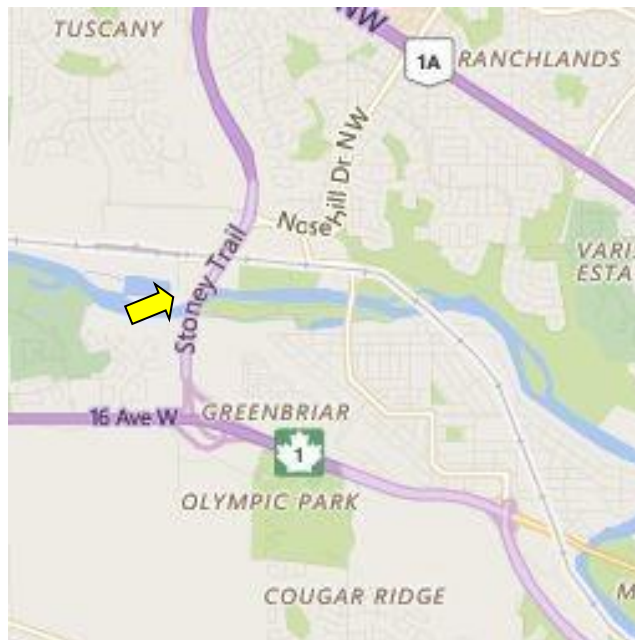
