Basically, the new guidelines come down to freedom to make informed decisions for ourselves, using common sense, and respecting the rights of others. Masking and social distancing, while not mandatory, are recommended by the province for public safety. If you choose not to mask, that's up to you, but please respect the decisions of those who have chosen to mask and realize that you should not invade their personal space, but rather social distance. The decision regarding masks in the ring is the decision of the judge. If the judge is wearing a mask, everyone in the ring will wear a mask.

Every effort was made to make the schedule as smooth as possible. We appreciate that a significant number of exhibitors involved in "Conformation" are also involved in "Obedience", "Rally-O" and Junior Handling! THE ARE NO CONFLICTS IN THIS SCHEDULE! Maybe a few close calls, but we're a relatively small entry with a whole day to get through 110 dogs. Our judges are patient and understanding so we promise you that not a single dog entered will miss a class due to a conflict! Be patient, be aware, let us know in advance and we'll wait! That's a promise!

Exhibitors are welcome to help set up for the show, starting at 6 pm on Friday, April 1, 2022. Many hands make light work, and once we finished set-up THEN volunteers may bring in their tables and crates and get everything arranged for the morning. There will also be an opportunity to practice in the rings. NKC will be holding a "Show 'N' Go" after the work is done @ \$5/dog.

MANDATORY** ALL EXHIBITORS MUST COVER THE FLOOR OF THEIR GROOMING AREA. Plastic, paper or fabric material which may be secured with Painter's tape. (Duct tape is NOT permissible) The floors have recently been replaced and there is a ZERO TOLERANCE POLICY for uncovered grooming space.

Newfoundland Kennel Club appreciates being able to have access to the Rec Centre at Buckmaster's Circle and would like to continue holding events in this facility. Unfortunately, it was left in less than stellar condition after the last show. We hope that each and every exhibitor will do their part to ensure that this venue is available to us for years to come. Exhibitors will be responsible for cleaning their set up area before leaving the venue each day. (Brooms and dust pans will

be provided).

Please do not put any liquids (e.g., half filled coffee cups, pop cans) in the garbage cans. Please empty them first.

SHOW ETIQUETTE

It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (See Section 19.7)

No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rul to the CKC within 14 days of the action. (Conformation Show Rules and Regulations 4.1.5.)

PLEASE NOTE THE FOLLOWING: No dog may be brought onto the grounds or premises of an event if it: 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease; 2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event); 3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease. Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

All exhibitors are required to clean up after their dogs. Clean up bags, garbage bins and tools are available for this purpose throughout the Show Site. THERE CONTINUES TO BE THOSE WHO DO NOT TAKE RESPONSIBILITY FOR THEIR DOGS, JEOPARDIZING THE CLUB'S ACCESS TO THIS VENUE. FOR THIS REASON, EX\HIBITORS WHO PERMIT A DOG TO SOIL ON THE SHOW GROUNDS WITHOUT CLEANING UP WILL BE DENIED ENTRY TO NKC SHOWS FOR ONE FULL CALENDAR YEAR IF CAUGHT.
