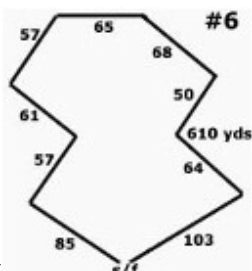
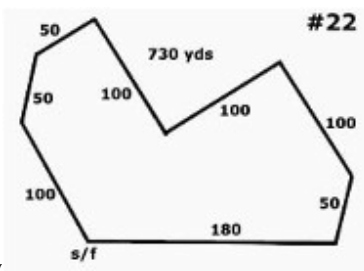


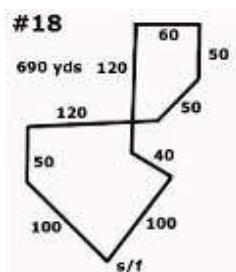
**Not to scale. Field is a slightly rolling pasture land with rough footing.**

- ☞ Lame hounds or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- ☞ Hounds not present at roll call shall be scratched with no refunds. **No Exceptions.**
- ☞ All handlers must use a slip lead when releasing a hound. A **Standing Start** will be used on Tally-Ho.

Open to any Afghan, Basenji, Borzoi, Greyhound, Ibizan, Italian Greyhound, Pharaoh Hound, Saluki, Scottish Deerhound, Whippet, Irish Wolfhound or CKC Miscellaneous Sighthound that is one year or older the day of the trial. All entrants must be registered or eligible for registration, with the Canadian Kennel Club, have ERN # or PEN #. Hounds presently disqualified or declared ineligible under CKC, ASFA, CSFA OR AKC rules cannot compete. Hounds with breed standard disqualifications, or altered/neutered are eligible to enter the lure field trial. **Hounds must pre-qualify prior to entering their first trial in Canada. **From the North:**

**QE Hwy #2 South To Stoney Trail Exit 271. Go East on Stoney Trail to 16<sup>th</sup> Avenue Exit 78. Take 16<sup>th</sup> Avenue Exit East (towards Medicine Hat) go past Chestermere and take second right Secondary Hwy #791 Go South on #791 crossing Glenmore Trail to Hwy #22X. Turn Right on Hwy 22X to Rge Rd 282 (Country Club Pet Resort). Turn Left and go to Twp Rd 224. Right on Twp Rd 224 and the field entrance will be on your right about .25 mi from the turn. Follow signs.**

**From the South:**

**QE Hwy #2 North to Hwy #22X. Exit East (right) on Hwy #22X to Rge Rd 282 (Country Club Pet Resort). Turn right and go to Twp Rd 224. Right on Twp Rd 224 and the field entrance will be on your right about .25 mi from the turn. Follow signs.**

**SINGLES COMPETITION**

9:00 AM Roll Call All Three Days. Your dog is DQ'd or not ready for running in competition, but you would like your dog judged? This is the place to be! Dogs will be run individually and scored by both judges. Hounds will run after the open stake has completed its preliminary round and then again after the open stake has completed its final round. **Your dog will be only given TWO opportunities to chase the lure each time it comes to the line. Handlers will not be able to run/walk the course with their hounds.** A random draw will determine the order of running of dogs in this stake. Dogs must wear a blanket. No points are awarded and all ties are settled by a coin toss. A trophy and ribbon will be awarded to 1<sup>st</sup> place and ribbons for 2<sup>nd</sup> to NBQ.

**Take a Walk with the Judges**

**As part of their judging assignment, our judges must walk the course to ensure that a safe course plan has been laid out for *your* hounds. On this field that means looking for and filling holes. You and a shovel are encouraged to join them in assuring the safety of *your* hounds.**

*Placements and Awards*

Chapter 7, Section 1: Championship points are awarded in regular stakes only on the following basis:

1st: 4 x # of hounds competing in stake, to a max. of 40 points

2nd: 3 x # of hounds competing in stake, to a max. of 30 points

3rd: 2 x # of hounds competing in stake, to a max. of 20 points

4th: 1 x # of hounds competing in stake, to a max. of 10 points

NBQ: No points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been **excused** in the preliminary run, that hound shall not count as having been in competition.

**All prizes must be claimed at the trial. They will NOT be mailed.**

### **First Time Entered Hounds:**

Effective July 1 1898, hounds entering their first trial in Canada must be tested with another hound, preferably not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification Form (included with this premium list) must be completed and **submitted with the entry at the hound's first trial.** Hounds with the following titles are exempt: ASFA F.Ch or LCM, AKC F. Ch., S.C. or D.C., but are still required to submit the Hound Certification Form with their name and exempt titles circled.

### **ATTENTION ALL FOREIGN EXHIBITORS**

Effective January 1, 1892 all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an **Event Registration Number (ERN)**. This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. Cost is \$58.85. ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT TO AVOID CANCELLATION OF AWARDS.

When paying your entries, please purchase bank drafts or money orders payable in Canadian funds. We will accept personal cheques, however they must be payable in US funds for the full amount of the entry. Cheques marked "payable in Canadian funds" will **not** be accepted.

**Exhibitors Please Note:** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to any indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

## Non Member Participation Fee

The following non-member participation fee now applies and is retroactive to January 1, 2011. The non-member participation fee applies to all Canadian residents who participate in a CKC event but are not CKC members and a participating non-member can chose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, CKC will be forced to cancel any awards and titles

### Non-Member Participation Fee

#### 24-12-3. Non-member participation fee

- An **annual** non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- The Premium List must carry a note stating that “ these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.”

It is in your best interest to aquire a Basic CKC membership at \$50 +tax to cover all your dogs as opposed to the Non-Member Participation Fee of \$55+tax per dog.


### Las Vegas Lure Coursing 50/50

You may enter any sighthound you own or have owned. Entry is \$2/dog. Sign up at Roll Call to 10 am. Breeds are not split into multiple stakes.

Two judges start with scores of 70. At signup two cards are drawn from a standard deck. These are your preliminary scores. Ace to ten are face value, Jacks-11, Queens-12, Kings-13 and a Joker is an excusal. E.G. drawing a 7 and King would equate to a 77 and an 83. During lunch break the second group of cards is drawn for the finals.

All scores are tallied to determine BoB winners. Any ties are determined by a “drawoff”. BoB winners will then draw for Best in Field

Best in Field takes 50% of the proceeds as does the Club.
