JUDGING PROCEDURE

Judging of the All-Breed Puppy Sweepstakes will commence at approximately 12:00 Noon. However if necessary a later starting time may be announced for any one or more of the rings. (See judging program for further details). Breed judging will start again at the scheduled time. Within each group, puppies will be judged in order of age, SEXES COMBINED.

3 to 6 months 6 to 9 months 9 to 12 months 12 - 18 months

RULES and AWARDS

All dogs between the ages of 3 and 18 months on the date of the show shall be eligible to compete, regardless of place of birth. All dogs entered in the sweepstakes must also be entered in a regular class at the All Breed Show, on the day of the Sweepstakes. Money received as entry fee for the sweepstakes will be pooled and divided as follows:

Best in Sweeps. 5% of entry fees received & Prize
1st in each class. 25% of entry fees received for that class
2nd in each class. 20% of entry fees received for that class
3rd in each class. 15% of entry fees received for that class
4th in each class. 10% of entry fees received for that class

The remaining 25% of all entry fees will be retained to cover administration cost. Rosettes will be awarded for Best in each Group and Best in Sweepstakes. Flat ribbons will be awarded for first to fourth place in each class. A prize from the Ottawa Kennel Club for Best in Sweepstakes will be awarded. If a dog is required for judging in one of the regular classes, judging of the sweepstakes in that group will be suspended until judging of the regular class has been completed.

BRED BY EXHIBITOR COMPETITION Saturday May 24, 2014

The Ottawa Kennel Club is pleased to offer an UNOFFICIAL CLASS COMPETITION for breeders who enter the Bred By Exhibitor Class. **This class is open only to dogs entered in the "bred by" class.** There is no additional charge for this competition. Judging in this competition will be held after each official class is completed at the breed and group level, by the regular breed judge. Each winner will be eligible to compete for Best Bred by Exhibitor in his or her respective groups. Each group winner of the Best Bred by Exhibitor will be eligible to compete for Best Bred By Exhibitor in Show. A judge will judge best Bred by Exhibitor in Show upon completion of General Specials. A flat ribbon will be awarded at the breed level. A Rosette will be awarded to all Group winners in this competition. A gift and rosette will be awarded to the Best Bred By Exhibitor in Show.

OWNER HANDLED (OH) Sunday, May 25, 2014

Rules for Owner Handled Competition

- S **Owner Handled Box must be checked** on entry form for each day that you are eligible (A * will indicate each OH dog listed in both the catalogue and on the Judging sheets.)
- S This is open to all **non-professional** owner-handlers. (Professional defined as anyone who has been hired to assist a handler or paid to handle or received remuneration or a licensed/permit judge). Dogs must be **OH** throughout the competition.
- S Judging of **OH** will take place after Breed Judging Competition.
- S **OH** Best of Breed will be selected from the dogs eligible to compete for BB.
- S If the BB is **OH** it will automatically be the **OH BB**.
- S If ineligible, then the next highest OH placement will compete against the eligible dogs of the opposite sex.
- S Should none of the BB competitive dogs be **OH** then any **OH** dogs (not directly or indirectly defeated in the classes by an **OH** dog) will be invited back.
- S The **OH BB** dogs will compete for **BOH** in Group immediately after Regular Group Judging.
- S Should the Regular Group 1st dog be **OH** then it will be automatically **OH in Group**.
- S If no **OH** places in the Group (1-4) then all **BB OH** dogs will be called into the ring for **OH Group Judging**.
- S If BIS dog is **OH**, then it will automatically be **OH BIS**
- S A prize and rosette will be offered for Best OH in Show. Rosettes will be offered for Best OH in Group.

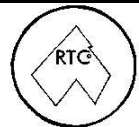

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

1. To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Show Secretary after the official closing date as published in this premium list. Section 1 Chapter 13.
2. No entry will be accepted unless all particulars called for on the entry form are shown thereon. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY THE ENTRY FEE.
3. TELEPHONE ENTRIES WILL NOT BE ACCEPTED.
4. Conflicts between Dog Show Rules and New Breed Standards. The Board of Directors of the CKC, has ruled that where there is a conflict between the Breed Standards and the Dog Show Rules that the Dog Show Rules will take precedence.
5. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellation of any entry after the closing day is prohibited.
6. The Ottawa Kennel Club reserves the right to refuse any entry, subject to C.K.C. Dog Show Rules.
7. THE SHOW SUPERINTENDENT WILL BE IN FULL CHARGE OF THE SHOW which will be governed by C.K.C.Rules.
8. Identification cards and judging schedule will be mailed as soon as possible after entries close.
9. The person accompanying the dog must show the Identification card before the dog is allowed in the show, and unless a dog is entered officially, it will not be allowed in the show precincts.
10. All dogs must be exercised in the exercise pens provided for that purpose. Plastic bags will be available at each entrance.

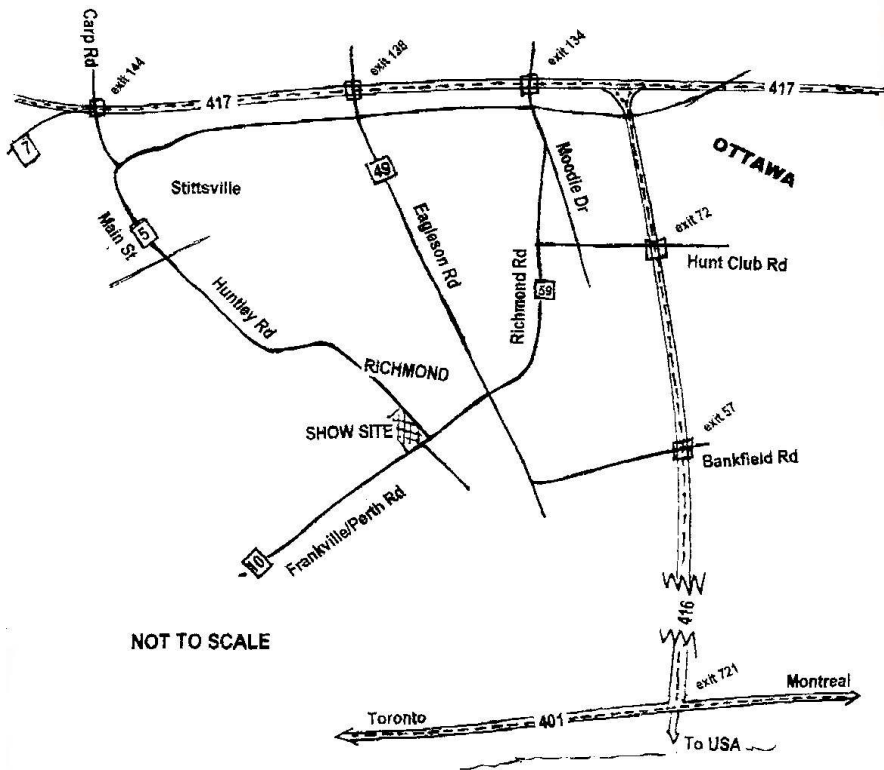
