All Province of Saskatchewan Health Authority (SHA) COVID-19 regulations will be followed.

PLEASE do not attend these trials if you are exhibiting any signs of illness.

****The Government of Saskatchewan/Saskatchewan Health Authority currently requires that Proof of Vaccination/Approved Negative Test result is required to attend and/or participate in this event. Masks are mandatory in all indoor public areas of the trial precinct. These items will be enforced unless otherwise specified at time of trial. ****

*Waiver must be signed by every competitor and provided at their mat time or first walk through.

NO SPECTATORS ALLOWED

*No Canteen

**Please maintain a physical distance of at least 6 feet from those not within your household.

COVID-19 CKC OBEDIENCE TRIAL ALLOWABLE CHANGES

- ◆ Handler will place their leash, dumbbells etc. in a designated spot and pick up after their run. The ring steward will NOT bring your leash to you. Your dog must leave the ring on-leash and under control.
- ◆ Pylons will be used for Figure 8 posts at all levels
- ◆ Group Stays – dogs will be placed a minimum of 8 feet apart for all levels. To accommodate the distance requirement, there may be more than one group. A dog that fails to qualify in the Individual Exercises will not be eligible to compete in the Group Exercise.
