<u>Directions to the show</u>: From St. John & Fredericton, Take exit 446 Moncton Centre-Riverview. Go straight and follow road for approx. 7.5 Km, Coliseum is on your left.

From Nova Scotia – Take exit 454 – Mapleton Rd. At the end of the ramp tlurn left on Mapleton Rd (arrow Moncton). Proceed through the lights here and continue straight until you come to Killam Dr. (approx 3.7 kms). Turn right on Killam Dr and continue straight for approx 1 km. Coliseum is on your right.
