#### Important Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

1. **No outdoor shoes allowed on the turf indoors.**  
**Please ensure you bring a clean, dry pair of indoor only shoes.**
2. Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
3. Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
4. Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
5. Please do your best to keep barking to a minimum.
6. Indoor crating is very limited. Please no ex-pens, shade tents may be setup outside or crate from your vehicle.
7. **No smoking, vaping or Cannabis anywhere on the property.**

Judges are not required to wait for dogs. The Handler of each dog is solely responsible for having it ready at the ring area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of locating dogs that are not brought into the ring when required.
