For the **TRACKING people**: to avoid tracks getting “over aged”, please be ready to MOVE and convoy when between sites..... Please park in a line on ONE side of the road behind the convoy lead.

CONVOY ORDER: Judge will lead. . Then, tracklayer if not already at the site,, followed by the dog to be running the track. Once you have run your track, please drop back to the back of the convoy and let the next person move up behind the judge.

You are responsible to be ready to go when the judge calls you....get your dog aired while the previous dog(s) are out working but AWAY from the tracking area..

Rally exhibitors:

Please bring your own chairs,, shade tents if desired, and park in the parking area NOT out on the road or in the house driveway.. You are welcome to swim the dogs in the west pond (beside the parking area) but they must be UNDER CONTROL and not able to interfere with the judging/dogs in the ring.

Please be available to help do course changes as needed.....more hands make light work!

DIRECTIONS:

From Highway 11 at Powassan, take exit 316.
Turn right at top of exit ramp, onto Clark St., and come into town.
Clark St ends at Main St. Turn right onto Main St.
Then take the first left: Memorial Park Dr.

We are 808 Memorial Park Dr., approx. 3.7 km east of Main St.

Parking for the trials is between the west pond and the fenced training/trial area., Please do NOT block the driveway.
