ADDITIONAL INFORMATION

- ◆ ONLY APPROVED CKC collars will be allowed in the precincts of the Trials.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ BITCHES IN SEASON: Obedience entry fees WILL be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) IF: a dated veterinarian's certificate is produced prior to the trial.
- ◆ THE PRECINCTS of these trials shall be the Pike Lake Hall. No dog will be allowed in the building unless entered in the Trials or Exhibition Only.

NON MEMBER PARTICIPANT FEE (April 20, 2011)

This fee applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

PLEASE NOTE: The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators. All dogs must be under complete control at all times.

DIRECTIONS: PIKE LAKE HALL

From 22nd Street West (in Saskatoon), turn left onto Highway 7 (just past the Walmart and Lowe's). Follow for 5 km. and turn left onto Highway 60. Continue on Highway 60 for 20 km. then turn left onto Churchill Avenue. Drive down Churchill Avenue for 600 meters (first intersection) and turn right onto Pippin Street. Pike Lake Community Hall is located approximately 2/3 of the way down this street or 170 meters on the left (between the Pike Lake Fire Hall and Pike Lake Community School).
