ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars ONLY. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal Cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par" as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.

NO ENTRY WILL BE ACCEPTED WITHOUT PAYMENT IN FULL. Tendering of an NSF cheque in payment of entry fees will be considered non-payment of entry fees and is an offence punishable by CKC disciplinary action and cancellation of awards.

The owner of a dog entered in this trial is entirely responsible for any error in the entering of his dog, regardless of how, or by whom the entry was made. All particulars called for on the entry form must be complete. No refunds are given due to an error in entries. The club reserves the right to refuse any entry, subject to CKC rules.

Benching

Limited, free on-site benching for the trials will be available within the trial precincts in designated areas. No power is available.

Photographer

A show photographer will not be available at this show. A photo area will be set up for you to take pictures of your wins.

Refunds

Entry fees will **not** be refunded in the event a dog is absent, disqualified, excused by the Judge, or barred from competition by action of the Trial Committee.

Entry fees will be refunded when a bitch entered comes into season after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the Trial Secretary on or before the starting date and the time of the trial. The Rocky Mountain Working Herding Club of Alberta will refund entry, recording and TCN fees if the above conditions are met. A 50% refund of entry fees only will be made for a bitch in season without a veterinarian's certificate with written notification presented to the Trial Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Trial Chairperson to verify she is in season. Refunds will be **MAILED** to the exhibitor.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, strikes, Federal, Provincial or Local requirements or any other cause beyond the control of the Club.

OFFICIAL OBEDIENCE CLASSES

REGULAR CLASSES

The following CKC classes will be provided:

PRE NOVICE	This is for any dog of any recognized or listed breed which has not earned the title of PCD. Dogs in this class may be handled by the owner or any other person. A dog that has earned the title of CD is not eligible for this class.
NOVICE A	This is for any dog of any recognized or listed breed which has not earned the title of CD. Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
NOVICE B	This is for any dog of any recognized or listed breed which has not earned the title of CD. Dogs in this class may be handled by any person. No dog may be entered in both the Novice A and Novice B class at any one trial.
NOVICE C	This is for any dog of any recognized or listed breed which has earned the title of CD or any higher obedience title. Dogs in this class may be handled by any person.
NOVICE INTERMEDIATE	This is for any dog of any recognized or listed breed which has earned the title of CD or any higher obedience title. Dogs in this class may be handled by any person.
OPEN HA / 18A	This is for any dog of any recognized or listed breed which has earned the title of CD but has not earned the title of CDX. Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. Any person who has previously trained or exhibited a dog that has earned a UD title may not handle a dog in this class.
OPEN HB / 18B	This is for any dog of any recognized or listed breed which has earned the title of CD. Dogs in this class may be handled by any person. No dog may be entered in both Open HA/18A and Open HB/18B at any one trial. A dog that has earned the title of CDX must compete in Open B. Dogs eligible for entry in the Utility Class are also eligible for entry in this class.
UTILITY A	This is for any dog of any recognized or listed breed that has earned the title of CDX but has not earned the title of UD. The dog must be handled by the owner or a member of his immediate family. Any person who has trained or exhibited a dog that has earned a MOTCH title may not handle dogs in this class.
UTILITY B	This is for any dog of any recognized or listed breed that has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. No dog may be entered in both Utility A and Utility B at the same trial.

NON-REGULAR CLASSES

VETERANS	For any dog that has earned the title of CD or higher and is 7 years old or older on the day of the trial. Exercises shall be performed and judged as in the Novice classes. Dogs entered in Veterans must also be entered in any regular class or exhibition only. Owner or any other person may handle dogs in this class.
EXHIBITION ONLY	Dogs entered in this class may not compete in any Regular class.

OFFICIAL RALLY OBEDIENCE CLASSES

REGULAR CLASSES

The following CKC classes will be provided:

NOVICE A	This is for any dog of any recognized or listed breed which has not earned the title of RN. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class. No dog may be entered in both the Novice A and Novice B class at any one trial.
NOVICE B	This is for any dog of any recognized or listed breed which has not earned the title of RN. Dogs in this class may be handled by any person.
INTERMEDIATE	This is for any dog of any recognized or listed breed which has earned the title of RN. This class is an elective class and earning the title is not a requirement to enter the Advanced classes.
ADVANCED A	This is for any dog of any recognized or listed breed which has earned the title of RN but has not earned the RA title or any CKC obedience title other than PCD. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
ADVANCED B	This is for any dog of any recognized or listed breed which has earned the title of RN. Dogs in this class may be handled by any person.
EXCELLENT A	This is for any dog of any recognized or listed breed that has earned the title of RA but had not earned the re title or any CKC obedience title other than PCD. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
EXCELLENT B	This is for any dog of any recognized or listed breed that has earned the title of RA. Dogs in this class may be handled by any person.
MASTERS	This is for any dog of any recognized or listed breed that has earned the title of RE. Dogs in this class may be handled by any person.

NON-REGULAR CLASSES

EXHIBITION ONLY	Dogs entered in this class may not compete in any Regular class.

GENERAL INFORMATION

1. **Obedience Trials & Rally Trials Rules and Regulations** are available from the **Canadian Kennel Club** or can be viewed [online](#).
2. The Trial Superintendent will be in full charge of the trial which will be governed by CKC rules.
3. Entries will be acknowledged after entry closing, with receipt, judging schedule and exhibitor passes. If such acknowledgement is not received one week before the trial date, please contact the Event Secretary.
4. "A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out" – **Obedience Trial Rules and Regulations** - Section 3.6.1.
5. We welcome all exhibitors, including persons with disabilities. If you require accommodation of a disability, please make your accommodation known to the club in advance. Please contact the trial secretary by entry closing to ensure that we can do our best to accommodate your needs.
6. The trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
7. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the trial grounds.

TCN FEES

A CKC TCN fee of \$10.50 (GST Incl.) Canadian or US per dog per show is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, ERN (Event Registration Number), PEN (Performance Event Number), MCN (Miscellaneous Certificate Number) or Companion Number. The Temporary Competition Number **MUST** be obtained from the CKC prior to entering any CKC event. TCNs will replace the previous system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). If a CKC registration number is received after the closing date but prior to the date of the show, this number may be added to the entry and noted in the marked catalogue. TCN fees will not be refunded.

ENTRY AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers, and patrons, know and abide by the "CKC Dog Trial Rules" and that I am (we are) familiar with their content. I (we) agree that the Rocky Mountain Working Herding Club of Alberta (RMWHCA) has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these trials, and of the holding of these trials and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Rocky Mountain Working Herding Club of Alberta, their members, directors, governors, officers, agents, superintendents, or trial secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the trial premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

Kindly note that the Rocky Mountain Working Herding Club of Alberta, and/or its agents, may take candid photos, win photos, or videos of the trial, including but not limited to, images of the exhibitors and their dogs. By entering the Rocky Mountain Working Herding Club of Alberta trial, you waive all rights to such images and agree that the Rocky Mountain Working Herding Club of Alberta may use them for its promotional or educational purposes, and without notice or compensation to you.

ATTENTION ALL FOREIGN EXHIBITORS!

All dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number but will require an ERN - Event Registration Number. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's registration certificate with certified cheque, money order, VISA or MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT. A CKC ERN registration form can be downloaded [here](#).

Information for US Exhibitors on entering Canada

- To enter Canada from the States, US Citizens must show proof of identity; however, to enter back into the United States, all US Citizens age 16 or older must have a valid Passport or Approved Secure Travel Document.
- Please be aware that all dogs must have a valid rabies certificate to cross the border. A valid rabies vaccination that has been given at least 30 days prior to entry into Canada is required. Government regulations require a rabies vaccination certificate be provided for each dog. NOTE: Dogs less than three months of age do not require rabies vaccination.

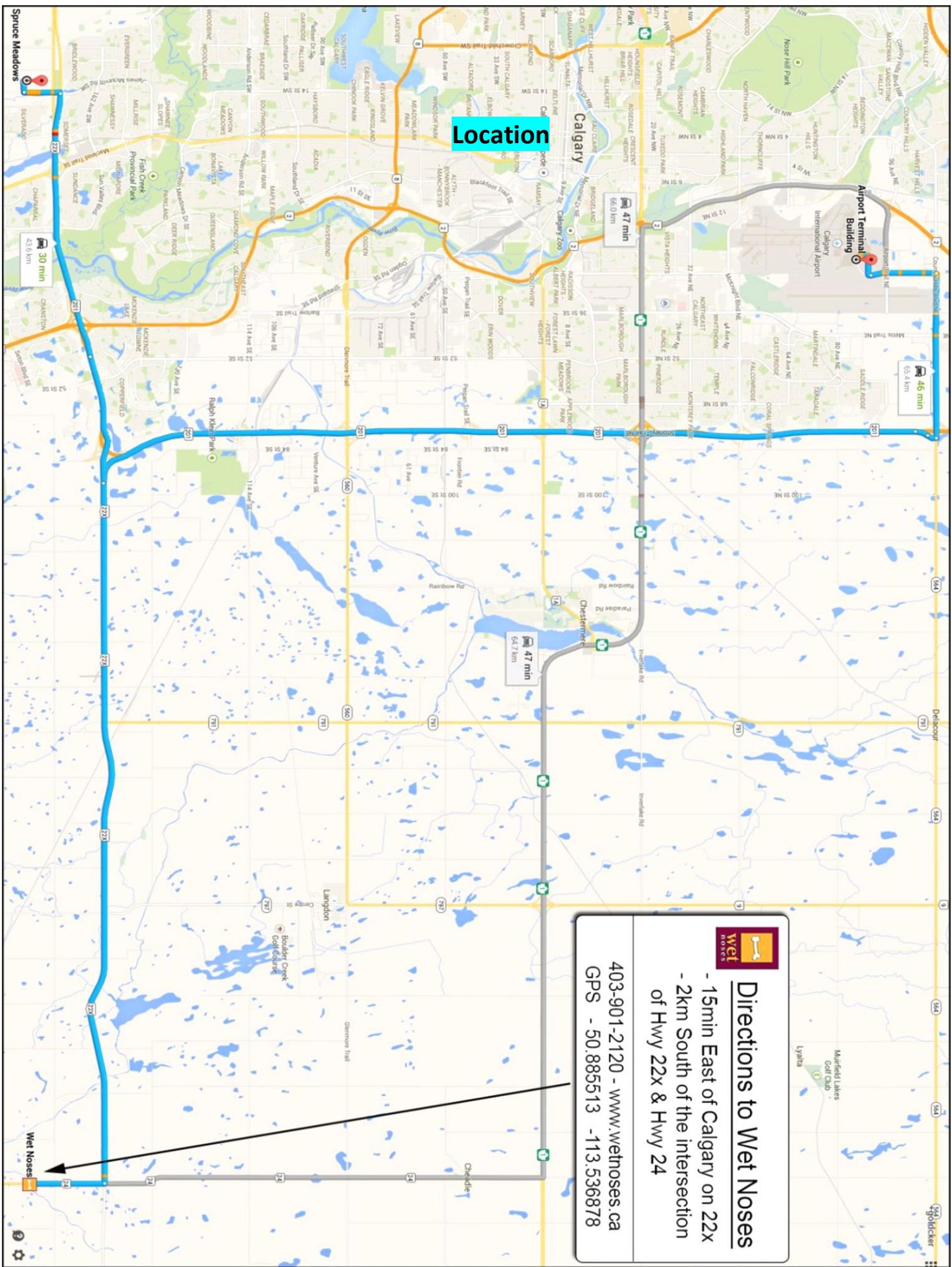
