OFFICIAL JUNIOR HANDLING

There will be Junior Handling **CONFORMATION** Saturday and Sunday. Registration will be in the Show Secretary's room in the morning, and must be done at least one hour in advance of the scheduled judging. Dogs competing in Junior Handling must be entered in one of the regular classes or in Exhibition Only. **A fee of \$2.00 for Junior Handling is required at time of registration**

CHAMPIONS AND CHAMPIONSHIP POINTS

The Schedule to be employed in the determination of points allocated a dog awarded a dog awarded "winners" shall be as follows:

A class dog awarded Best in Show at any All Breed Championship Show will be credited with Five (5) points inclusive of any points earned at the breed and group level. In no case may a dog earn more than five points at a single show. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

ENTRY INFORMATION

1. Attention U.S. Exhibitors: A Personal cheque will be accepted, however, it must be payable in US funds and for the full entry amount. Personally discounted cheques will not be accepted. Do not mark cheque "payable in Canadian" or "funds at par". Your co-operation is appreciated.
2. If entering the same dog in conformation, obedience or exhibition only please use a separate entry form for each class.
3. An **INCOMPLETE ENTRY FORM WILL BE RETURNED.** Please ensure that your postal code is included. ALL NSF CHEQUES WILL BE CHARGED A \$20.00 SERVICE CHARGE.
4. Exhibitors must abide by the errors made when making the entry, regardless how or who made the entry.
5. An entry will not be accepted unless accompanied by the required fees.
6. The Cobequid Dog Club reserves the right to reject any entry subject to CKC rules.
7. Only dogs, which are eligible for registration or are registered by the CKC, may be entered in these Show & Trials.
8. Overpayment of entry fees up to a maximum of \$5.00 will be considered a donation to CDC Trophy Fund.
9. The Exhibitor is responsible for knowing and complying with the Dog Show Rules of the CKC.
10. **There will be no prong or spike collars permitted at this venue.**
11. Conformation Show - Move Up Chapter 13, Sec. 13, of the Dog Show Rules:
"A dog which is individually registered in the records of the Canadian Kennel Club and has completed the requirements of championship in accordance with the provisions of Chapter 20 of these rules, after closing date and time for entries of the show, but whose championship is unconfirmed by CKC may be transferred from one of the regular classes to Specials Only providing the request for transfer is submitted by owner or handler to the Show Secretary, **IN WRITING**, at least one hour prior to the opening of the show."
12. Obedience Trial - Move Up A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules, may be moved to the next level of Obedience competition providing the transfer was submitted to the Trial secretary, **IN WRITING** by the owner or handler, one hour prior to the opening of the first trial, trial schedule permitting.

GENERAL INFORMATION

THE PRECINCTS OF THE SHOW WILL BE THE SHOW BUILDING AND ENTRANCE. The show premises will be Opening at 7:00 am each day and on Friday October 6 from 4:00-8:00pm (sharp) for early set up. The Show/Trial Judging will start at 9:00am unless entries warrant an earlier start. Judging schedule and identification will be mailed as soon as possible after the entry closing date. Identification of an accepted entry for dogs must be presented at the entrance to the show premises, and only dogs entered in the shows and trials will be permitted to enter the venue. The Cobequid Dog Club will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of an accident or other misfortune to dogs, exhibitors or patrons. Judging will not be delayed to accommodate an exhibitor or handler who fails to have his/her dog in the ring when required. The Show Superintendent will be in full charge of the shows and trials. Exercise pens will be restricted at the discretion of the Show Superintendent. Only dogs entered in the show are permitted within the show precincts please. Electrical outlets will not be available to exhibitors. CANTEEN service provided.

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles.
