- Exhibitors or handlers are solely responsible for having their dogs at ringside when classes are called. It is not the responsibility of the Ring Steward to locate dogs. Absentees should be reported to the Ring Steward. Judges will not wait for any dogs not present when called. Judging will not be delayed by waiting for an exhibitor or handler in another ring – please arrange to have alternate handlers available. Your cooperation is appreciated.

- The Show & Trial Superintendent will be in full charge of shows, which will be governed by CKC rules.

- To comply with Province of NB regulations NO SMOKING will be permitted within the confines of this building.

- The ALRC and River Valley Community Centre will not be held responsible for any equipment left in the building overnight. No dogs will be allowed in the building overnight.

- All exhibitors will be held responsible for clean up on the show grounds and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.

- Children are welcome and must be accompanied by adults at all times. Please do not allow them to run amongst the dogs or set up areas or disturb or touch dogs without permission of owner/handler.

#### DIRECTIONS TO SHOW SITE RIVER VALLEY COMMUNITY CENTRE 749 RIVER VALLEY DR, GRAND BAY-WESTFIELD, E5K 1B6

Coming from East/Moncton/Nova Scotia/ Prince Edward Island

Continue on NB-1 West past Saint John Take Exit 114 (approx 8 km after Harbour Bridge) onto NB-7 for Grand Bay-Westfield/Fredericton Drive approximately 6 km, take Exit 90 for Grand Bay-Westfield Drive approximately 6.5 km, the arena is on the left

Coming from USA(Calais, ME, St Stephen)

Take NB-1 East toward Saint John, continue approx 100km Take Exit 114 onto NB-7 for Grand Bay-Westfield/Fredericton Drive approximately 6 km, take Exit 90 for Grand Bay-Westfield Drive approximately 6.5 km, the arena is on the left

Coming from Fredericton/Quebec

Continue on TC-2 East Take Exit 306 onto NB-7 South toward Saint John, continue approx 60km Take Exit 80 for Grand Bay/Westfield, turn left at end of ramp and proceed down hill At flashing light turn right onto Nerepis Rd Drive approximately 6 km, arena is on the right
